To the Honorable Commissioners Court
of Burnet County:

In obedience to an order of
your Court dated Nov. 11th 1884
requiring me to meet the Llano County
Surveyor on the 17th of February 1885
at the mouth of Slick Rock Creek
for the purpose of surveying the County
line between Burnet and Llano I
beg leave to submit the following report:

I went to said point at the
time appointed but the Llano Surveyor
failing to meet me at ^{the} time I proceeded
to make the survey alone measuring
said line carefully and establishing
stone mounds, ~~over~~ two feet high
every mile, as the law requires

I was informed while doing this work
that Mr. W^m Kyle Surveyor of Llano Co.
had run a line for said County
boundary parallel with the one I
run and about 550 vs. further
East but that he had not chamed
nor made mounds on said line

I was on said line as pointed
out to me by the man who said

Burnet Co. Gary Line # 122

he blazed the same for Mr. Kyle; was at a point on said line five miles from the River and found neither Post nor Mound for the termination of the same, and traced the same for more than a mile being newly blazed besides having old hacks being once run for a division line of the John Darlin League and I found neither Post nor mound at any point on said line

I ascertained upon returning home that by a mistake as to the time set for said Survey that Mr. Kyle had been notified to meet me on the 11th instead of the 17th. a fact which prevents my offering field notes of my survey with this report



Statement of Survey of Co.

It was ordered by the Court, that said report be received and recorded.

And it appearing to the Court, that by mistake there was no lawful survey made of said line, and that the survey of the line made by W^m Kyle, Surveyor of Blanco Co., is illegal, because not measured, marked and defined by Posts or mounds as required by law: Therefore, said work by Surveyor of Blanco County is not accepted or approved by this Court.

That the Protest of this Court, be entered against this line; and Notice by Copy of the above report, and of this order, be forwarded to Commissioner of General Land Office, at Austin Texas, and a request that he do not accept - approve or regard said work by W^m Kyle Surveyor of Blanco County
