Jones southwest corner of Lubbock County, and that said southwest corner of Hockley County and southeast corner of Cochran County is marked by a large concrete stone partly imbedded in the ground by Surveyor Harris and that the county boundary line between Hockley County and Cochran County is practically a straight line between the aforesaid southwest corner of Hockley County and the southeast corner of Cochran County on the south and the aforesaid southwest corner of Lamb County and the southeast corner of Bailey County on the North as established by the said W. H. Tilson-W. D. Twichell and W. J. Williams, and that the County Courts of Hockley County and Cochran County in the year 1937 legally appointed Surveyors W. J. Williams and A. L. Harris respectively to survey said boundary line between Hockley County and Cochran County and that when a disagreement arose between the two said Surveyors as to the course of said survey from the south end of said line their difference was duly certified to the Land Commissioner of the State of Texas, as required by Law, and that the said Land Commissioner ruled that the said boundary line should be a practically straight line between said Harris corner on the south and the southwest corner of Lamb and southeast corner of Bailey on the North as marked on the ground as the Tilson-Williams-Twichell corner as more fully described above, and that thereafter the said W. J. Williams, in obedience to the orders of said Courts and the ruling of said State Land Commissioner, and in compliance with Law, surveyed and marked on the ground the said boundary line between Hockley County and Cochran County as more fully shown by field notes and map on file with the County Clerk of Hockley County, Texas, and as per field notes made by the said W. J. Williams covering said boundary line between Hockley and Cochran Counties and copied and adopted herein, and the Court finding that the aforesaid boundary line between Hockley County and Cochran County and between Lamb County and Bailey County as described is the true and legal boundary line, and that the corners above described are the true and legal corners of said Counties as described, and should be decreed and adjudged to be such by this Court.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED BY THE COURT this the 16th day of December 1940, that the county boundary line between

and the Southeast corner of Bailey County, and placed at said corner a concrete monument 4"x4" on top and 6"x6" on the bottom and 30" long marked southeast Bailey-southwest Lamb-NL Cochran, set by the side of a limestone 17" x 12" x 11" marked WHT-L, and the Court further finding that said Surveyors, W. D. Twichell and W. J. Williams at said time found, located and established the northwest corner of Lamb and the northeast corner of Bailey Counties and marked same by a concrete stone 4"x4" on top and 6"x6" on the bottom marked SE Parmer-NE Bailey-NW Lamb, whence a large cedar post marked PB Lamb bears south 21.2 and east 27.5.8 Said northwest corner of Lamb County and northeast corner of Bailey County as marked by the said Twichell-Williams being thirty miles west from the northwest corner of Hale County, and the Court further finding that the aforesaid Twichell-Williams line marked upon the ground for the common boundary line between Lamb and Bailey Counties is substantially a straight line between the aforesaid southwest corner of Lamb County and the aforesaid northwest corner of Lamb County, and the Court further finding that the said Twichell-Williams line was actually surveyed and marked on the ground in the year 1916 in accordance with the action of said County Courts and that thereafter and at all times since said line has been recognized by Lamb County and by Bailey County and by the General Land Office as the County boundary line between Lamb County and Bailey County, and also that said line has been validated by the Acts of the Legislature as the true boundary line between said Counties, and the Court further finding that said Twichell-Williams line surveyed on the ground as the boundary line between Lamb and Bailey Counties is definitely shown by the Williams-Twichell field notes of said line as herein shown, and the Court further finding that the above concrete monuments respectively marking and identifying the northwest corner of Lamb and the northeast corner of Bailey and also the southwest corner of Lamb and the southeast corner of Bailey are still in existence and on the ground at said place, except that the Williams-Twichell concrete marker is lying upon the ground, and that since it was established at said place the Harris large concrete marker, of much larger proportions has been moved to said corner and imbedded in the ground, and the Court further finding that the southwest corner of Hockley County and the southeast corner of Cochran County is located at a point approximately thirty miles

FINAL BOUNDARY JUDGMENT:

BE IT REMEMBERED, that on the 9th day of December, 1940 came on to be considered the above styled and numbered cause and came the Plaintiffs, Cochran County and Bailey County and also the Defendants, Hockley County and Lamb County, all by their attorneys, and announced ready for trial, and a jury being waived and all matters of law and fact having been submitted to the Court, and the Court having heard the pleadings, evidence and argument of counsel, and finding that this is a suit primarily to establish the county boundary line between Lamb and Bailey Counties and also the county boundary line between Hockley County and Cochran County, and the Court finding that the said County boundary line between the counties of Lamb and Bailey was first surveyed and marked on the ground by W. H. Tilson, surveyor, in 1910, and that the said W. H. Tilson likewise located, established and marked the southwest corner of Lamb County and the southeast corner of Bailey County at a point, (established to be approximately thirty miles plus 887 varas west of the Ira Millington southwest corner of Hale County,) which southwest corner of Lamb County and southeast corner of Bailey County was marked and identified by the said W. H. Tilson in 1910 by placing at said southwest corner of Lamb County and southeast corner of Bailey County a limestone approximately 17" long by 13" wide by 11" thick bearing the letters WHT with the letter L thereunder, and the Court further finding that said county boundary line between the counties of Lamb and Bailey in 1916 was ordered surveyed and marked on the ground by the County Court of Lamb County and the County Court of Castro County, (to which Bailey County was then attached for judicial purposes) and that Lamb County appointed Surveyor W. D. Twichell to represent it in the survey of said line, and Castro County appointed Surveyor W. J. Williams to represent Bailey County in the surveying of said county line, and the Court finding that said two Surveyors surveyed and marked said boundary line between the two said Counties substantially the same as was first surveyed by the said W. H. Tilson in 1910, and that said two surveyors likewise found, located, marked and identified the aforesaid W. H. Tilson corner as the southwest corner of Lamb County
