

The State of Texas, Field Notes of Six
County of Cooke $\frac{3}{4}$ Miles of the South
Boundary line of Cooke County, made
in pursuance of an Order of the County
Court of Cooke County Entered at the
May Term A.D. 1859.

Beginning at the North West Corner of
Sinton County which is described as
follows, a rock 3 inches thick one foot
broad and two feet long on a large
flat rock about one Chain wide by
two Chains long on which runs a
branch or spring apparently a living
one which falls down a cascade
bearing N 65° E. 1.88 chains a live oak
10 in dia N.W.C.D. bears, S 88 $\frac{3}{4}$ ° E. 8.18.
chains a live oak 9 in dia N.W.C.D. bears
S 88 $\frac{1}{2}$ ° E. 9.13. chains and a live oak N.W.C.D.
D. bears North about 3 chains

Thence West ~~at a distance of ten~~
1900 varas a mound of dirt on the high
Prairie

Thence West 1900 varas a rock about
3 inches thick and two feet square upon
which was cut C.I.D. about 30 varas East
of a dry ravine

Thence West 30 varas ravine at 420 varas
do. at 1240 varas do. at 1620 varas do. at 1900
varas a pile of stone on the East side of a
hill

Thence West 1420 varas. One of the head
branches of Carr hollow. at 1900 varas
pile of stone from which a Grove of
Cypresses standing on the Bank of Branch

hrs. East 480 yards.

Thence West 1900 yards. two rock were
mkd C I the other S M. from which an
Olm on the bank of Ravine hrs. West 480
yards. Marked F.

Thence West at 480 yards. branch of
Dutton Creek. at 1900 yards. the S W corner
of Cooke County. a pile of rock or two
feet high 40 yards. West of a dry ravine
the top stone mk S. W. C C C & C. from which
a grove of timber. on one of the branches
of Dutton hrs. S 41 E. 1 mile distance.
