Boundary lines January 1st 1889.

Crosby County begins at an
earth and stone mound on
plain 3 ft high and 5 ft dia mkd
N.E.C. 1117 vs S and 1161 vs
E of the N.W. cor of sec N^o 4 1/2
cut^y N^o 466 A.B. & M. sur in Blk
H. Under said mound is a
black bottle containing a paper
on which are written the words
"N.E. cor of Crosby County.

 corner of Crosby County.
