There is a fine Red Oak ridge of timber land jutting down between Rowlets Creek and the East Fork to the last mentioned stream--this is the only timber we have seen, save some in the bottom of cottonwood--So far our course has been in an almost impenetrable jungle of brush, vines and briars, so tied & bound together as to render it next to impossible to get a sapling to the ground, without clearing acres of land.- We manage to cut an Archway sufficient for our compass, chain and pack horse, but advance but slowly-I presume that a good crossing of the East Fork might be had by following



the above mentioned ridge to the East fork and selecting a good route through the bottom on the opposite side at all events we should have bottom land only on one side of the stream--80.00. 6th Mile Post in thicket $\overline{\underline{X}}$ Mulberry 4 inches N W 17 links, Elm 6 inches N E 17 links 80.00. 7th Mile Post in thicket White Hawthorn 4 inches South 7 links Hackberry 8 inches West 13 links \overline{X} .

Friday June 14th still water bound, and water rappidly increasing. Camp drowned out and forced to make a midnight escape half a mile through an almost impenetrable thicket, dark as pitch, in the meantime, the water climbing up our legs with a most alarming rapitity, this with the strong probability of not reaching the highland in the darkness caused some very disagreeable reflections, among which the very strong probability of roosting in a tree until the waters abated was not the most agreeable, however we were fortunate and by a lucky chance or perhaps instance reached the hill in safety, still the rain poured down in torrents, wet everything we had, ruined most of our provisions, and left us nearly surrounded by seas of water.

The South boundary of this survey running up the divide between ten mile and Red Oak creek, passes one excellent prearie --The first five miles, however, in the run bottoms has neither timber nor land that can possibly be cultivated, a flat of wet muskeet or Locust land is found between Millers and the widow Kirklands, but from this point the land continues excellent quite to the corner in Mountain Creek Valley. The inhabitants on this side of the river possess a treasure of no little value, in the Cedar Mountain, which affords cedar timber in great abundance -- This Mountain rises out of a plain to the probable height of 5 or 6 hundred feet stretching along from the South West corner of the County in a direction North East terminating near the West Fork. The Summet of this hill is entirely covered with cedar the base being maked prairie, this would seem to anser that in this climate, a considerable elevation is necessary to the growth and developement of this kind of tree. It is true that it it is occasionally found in scattering patches in the neighbourhood of Dallas, but not in sufficient quantities to warrant us in the belief that the soil and climate are there entirely congenial to its growth and increase --
