W. A. Trimble..... : No. 575, Vol. 30, In the name of the State of Texas.

To all to whom these presents shall come, know ye. I, Sam Houston, Governor of the State aforesaid, by virtue of the power vested in me by law, and in accordance with the laws of said State, in each case, made and provided, do by these presents grant to W. H. Witt, Assignee, of William A. Trimble his heirs or assigns forever, three hundred and twenty acres of land situated and described as follows: In Dallas and Denton Counties, one half in each county, on the waters of Elm Fork of the Trinity River, about $17\frac{1}{2}$ miles above Dallas and $12\frac{1}{2}$ miles below Alton, by virtue of augmentation certificate issued by the County Court of Tarrant County to said Trimble as a settler in Peters Colony and by virtue of his marriage in time to secure said additional amount of land, by said Wm. A. Trimble, transferred to Owen Blacker, 9th January 1853, and by said Blacker transferred to W. H. Witt, on the 14th January, 1854.

Beginning at a stake in the west line of John H. Mounts 320 acre survey, from which the N W corner bears North 380 vrs. an Ash marked X brs S 37° W 7 varas and an Elm marked X bears S 37° W--- varas, Thence West 1900.8 vrs, a stake an Ash mkd X brs S 20° W $5\frac{1}{2}$ vrs, and Elm brs-----, Thence South at --- vrs, Denton Creek g, S. E. 950.4 vrs. the N W corner of Jas. M Bakers survey, a stake an Elm mkd. X brs,-----, Thence East 1900.8 vrs to the N E corner of said Bakers survey, Thence North with Mounts W line 950.4 vrs to the beginning.

Hereby relinquishing to him the said W. H. Witt, and his heirs or assigns forever all the right and title in and to said land, heretofore held and possessed by the said State and I do hereby issue this Letter Patent for the same. In Testimony Whereof, I have caused the Seal of the State to be affixed as well as the Seal of the General Land Office. Done at the City of Austin on the Seventeenth day of October in the year of our Lord One Thousand Eight Hundred and Sixty.
