of Zavalla, Texas made by virtue of ^{and} in accor-
dance with an order of the County Commissioners Court
of said County, issued at the May Term of said Court
1891.

Began at the established S.W. Cor of Zavalla County
Texas, said corner being a L.O. post 10" dia. ^{and} 4 1/2 feet high
from which a L.O. 18" marked \equiv bears N. 85 E. 37 Vrs.
A do 12" dia marked \equiv bears N. 81 E 31 vrs ^{and} a 3 pronged
mes 14" dia marked \equiv bears N. 89 1/2 W. 51 Vrs.

Thence (at a variation of 9° 20' East)




