Report of the Survey of the  
West boundary of Nueces County and East  
boundary of Duval County made by the County  
Surveyors of said Counties by order of the County  
Commissioners of those Counties.

Beginning at a permanent corner of stone and  
mortar erected by the Surveyors of Live Oak, Duval  
and Nueces Counties on the South boundary line of  
Live Oak County and six miles East of the S.W. corner  
of Live Oak County, whence a  $\text{Meyt. } 7^{\text{in}}$  in diameter  
marked **I**, bears  $\text{N. } 39^{\circ} \text{W. } 7^{\text{m}}$  and a forked  $\text{Meyt. } 5^{\text{in}}$  in  
diameter, marked **V** bears  $\text{S. } 30\frac{3}{4}^{\circ} \text{W. } 8\frac{3}{4}^{\text{m}}$

Thence South with a variation  $9^{\circ} 30' \text{ E.}$  at  $330^{\text{m}}$   
top of a small hill  $20^{\text{m}}$  East, at  $900^{\text{m}}$  the Salcito bears  
 $\text{S. } 79\frac{1}{2}^{\circ} \text{W.}$ , at  $2467^{\text{m}}$  the North bank of Lagarto Creek-  
course  $\text{N. } 89^{\circ} \text{E.}$ , at  $2496^{\text{m}}$  the South bank Lagarto and C.  
Trevinos field fence, at  $2714^{\text{m}}$  crossed a field, at  $3686\frac{1}{2}^{\text{m}}$  South  
corner of Valdeck bears West  $794^{\text{m}}$ , at  $4000^{\text{m}}$  top of divide  
between Botello and Lagarto Creeks, at  $4533^{\text{m}}$  the  
North bank of Botello Creek, course  $\text{N. } 73\frac{1}{2}^{\circ} \text{E.}$  at  
 $4560^{\text{m}}$  the South bank of Botello Creek - passed at  
the lower end of a water hole. -, at  $5429^{\text{m}}$  Salcito  
bears  $\text{N. } 62^{\circ} \text{W.}$  at  $5700^{\text{m}}$  set the 1st League (3rd mile) post.  
At  $3480^{\text{m}}$  road from Alamo to Maudites, at  $3725^{\text{m}}$   
Salt Branch or Maudites Creek, at  $4577^{\text{m}}$  the S. W. corner  
of T. Sanchez - S. E. corner of D. Maudites, and N. E. corner  
of ~~Fabian~~ Fabian Fraela's homestead bears West  $703$

at 5220<sup>00</sup> road from Corpus to Mendocino, at 5700<sup>00</sup>  
set the 2nd League (6th Mile) post. - marked D on the  
Westside, N on the East, and II on the North side.

At 980<sup>00</sup> Chaco de Cuellar, at 1225<sup>00</sup> road from San Diego  
to Oakville, via Alamo Rancho, at 1649<sup>1/2</sup> J. C. Cuellar's  
S.W. corner bears West 212<sup>00</sup>, at 2731<sup>00</sup> the N.E. corner of  
Filameno Garcia bears West 235<sup>00</sup>, at 3105<sup>00</sup> a road, at 3565  
the Junta Creek - East - at 3910<sup>00</sup> road to the Amargosa, at  
3940<sup>00</sup> a stake, at 5250<sup>00</sup> the S.W. corner of Ramon  
Cuellar's Homestead bears East. 498<sup>00</sup>, at 5700<sup>00</sup> set  
the 3rd League post (9th Mile) - marked N.D. III.

At 4300 set a forked Mesquite post, at 4613 the  
North fence of Edwards G. House, at 4803<sup>00</sup> out of field,  
at 5340<sup>00</sup> the Chilitipin - runs East. - at 5700<sup>00</sup> set the  
4th League (12th Mile) post. marked N.D. + IV. At  
2950<sup>00</sup> a stone quarry on hill near E. G. Perez' Rancho, at  
3350<sup>00</sup> road from San Diego to F. W. Schuffus and also  
to the Cuellar's Rancho, at 3695<sup>00</sup> into Encarnacion  
G. Perez' field - drove stake and marked posts - at  
3925<sup>00</sup> Mauticito Branch, at 4200<sup>00</sup> out of field, at  
5700<sup>00</sup> set the 5th League (15th Mile) post marked N.D. + V.  
at 730<sup>00</sup> San Diego road - S. 10° E. - at 5282<sup>00</sup> road by  
Filipis, at 5700<sup>00</sup> set a sillar (large rock) for the 6th  
League (18th Mile) post. marked VI. N. D. At 2740<sup>00</sup>  
road from Alamo, at 3210 road from Oakville -  
bears S. 5° W. <sup>see below</sup> at 4185<sup>00</sup> Amargosa road at 4400<sup>00</sup>  
Corpus Christi road, at 4658<sup>00</sup> a post <sup>at</sup> the N.W. corner  
of Santos Martinez house bears West 31<sup>00</sup> (this  
point is in San Diego) at 5000<sup>00</sup> center of San Diego  
\* at 3264 same road again at 3620<sup>00</sup> crossed  
corner of field, at 3660<sup>00</sup> road from Oakville bears  
S. 5° W.

Creek, at 5060<sup>00</sup> a stake on the South bank of San Diego Creek, at 5200<sup>00</sup> the North fence of J. M. G. Divinos, at 5380<sup>00</sup> the Corpus Christi and Lando road, at 5700<sup>00</sup> set the 7th League (21st Mile) post marked VII N.D.

At 423<sup>00</sup> road from Trinidad to San Diego, at 2870<sup>00</sup> Deramedes, Palo Blanco, at 3630<sup>00</sup> South boundary of aforesaid pasture, at 5700<sup>00</sup> set the 8th League (24th Mile) post marked VIII. N.D.

At 2489<sup>00</sup> the S.E. corner of San Leandro bears East 3242<sup>00</sup>, at 5700<sup>00</sup> set the 9th League (27 Mile) post marked IX N.D. - near el Rancho de la

Copita. At 740<sup>00</sup> the S.E. corner of Jesus Divino's Homestead bears West 48<sup>00</sup>, at 840<sup>00</sup> the Narcisero Creek runs S. 35° E., at 2217 crossed the South boundary line of Apolonio Hinojosa's Homestead. 431<sup>00</sup> East of its S.W. corner. at 5700<sup>00</sup> set the 10th League (30th Mile) post marked X. N.D. - A. Mendosa's door bears N. 63½° E., J. M. Martinez's door bears N. 83° E. Eugenio Hinojosa's house bears S. 62¼° E.

At 720<sup>00</sup> Road, at 1500<sup>00</sup> Corpus Christi and Piedras Road - bears N. 80° W., At 1517 the N.E. corner of Hinojosa's Homestead bears West 686<sup>00</sup>, at 1650<sup>00</sup> the Guajillo Creek - runs S. E., at 4735<sup>00</sup> Road by Trinidad and Palo Blanco, to Piedras Pintas - West, at 5456<sup>00</sup> the North boundary of the Anacuas line, at 5700<sup>00</sup> set the 11th League (33rd Mile) post - marked XI. N. D. in the N.W. side of the Laguna de los Encurados, At 1938<sup>00</sup>

Road from Palito Blanco to J. M. Valdez' Rancho,  
at 2040<sup>ms</sup> the Anacuas Creek, at 5700<sup>ms</sup> set the  
12th League (36th Mile) post - marked XII. N. D.

At 367<sup>ms</sup> the S. E. corner Anacuas, and N. E.  
corner of D. Elizondo - better known as, "El Señor  
de la Carrera". bears West 1157<sup>ms</sup>, at 5700<sup>ms</sup> set  
the 13th League (37th Mile) post - marked XIII. N. D.

At 1210 Road from Corpus to Concepcion,  
bears N. E., at 2494<sup>ms</sup> old road to Con-  
cepcion, at 3284<sup>ms</sup> the S. W. corner of  
Juan Morino bears West 1138<sup>ms</sup>, at 4546<sup>ms</sup>  
the Uracas Creek - runs E. S. E. -, at 5700<sup>ms</sup>  
set the 14th League (42nd Mile) post - marked  
XIV. N. D.

At 5700<sup>ms</sup> set the 15th League (45th Mile)  
post - marked XV. N. D.

At 106<sup>ms</sup> the North line of Guzman's pasture  
fence, at 602 South boundary fence of said  
pasture, at 1503 Los Olmos Creek - runs  
S. E. -, at 3500 out of timber, - at West  
end of Laguna., at 5700<sup>ms</sup> set the 16th League  
(48th Mile) post, - marked XVI. N. D.

At 5700 a post in the prairie for the 17th  
League (51st Mile) post 17. N. D.

At 1020 the Cibola - runs S. E. -, at 5700<sup>ms</sup>  
set the 18th League (54th Mile) post, marked  
XVIII. N. D.

At 2920<sup>ms</sup> the Arroyo Laboritas - runs S. E.,

at 3800 (36 Miles) set a post marked D. N. H  
and 56. - A Mesquite (in Arroyo Laborcitas)  
bears N. 87° E. about 600<sup>0</sup>, another lone Mesquite  
on extreme right of Mott bears S. 63½° E. - a  
lone Mesquite in or near Arroyo bears N. 38½° W.
