on Monday the 12<sup>th</sup> day  
of March A. D. 1877 there was begun &  
holden in the Town of Saw Digo Tarrant  
County Texas, at the Court House thereof  
an ordinary session of the County Comm-  
issioners Court in and for said County  
the Hon James C. Luby County Judge  
Presiding

And among other matters on the 13<sup>th</sup>  
day of said month and at said time  
the following enactment was had,

Be it ordained and decreed by this Court  
that the County Surveyor John J. Dix Esq<sup>r</sup>  
be and he is hereby appointed a special  
Commissioner for and in behalf of Tarrant  
County, to run, establish and well define  
the Boundaries of Tarrant County and  
erect permanent Monuments of Stone  
at each of the several Corner Corners of  
said County, and take bearings of the  
most noted permanent objects near thereto  
as in other surveys, &&&

And that the said John J. Dix Esq<sup>r</sup>  
Surveyor of Tarrant Co, be and he is hereby  
instructed to proceed with a Commissioner  
or Surveyor on the part of Live Oak

Daniel Co. Bdry.  
Line # 3

M<sup>c</sup> Mullen and Puceos Counties as  
has been Solicited of them, if their Coop-  
eration can be secured or obtained in  
a reasonable time, (or alone: See act: 1873  
Paschal Digest 2<sup>d</sup> Digest) to the Nearest  
fixed and definitely established corner  
of any County, they may deem expedient  
and thence run in conformity with the  
Boundary lines of the several adjoining  
Counties as by law established, in such  
a Manner and in conformity with the  
laws establishing such Counties so as  
to definitely & accurately establish the  
aforesaid N. E. Corner of Suval County,  
being also the NW Corner of Puceos Co  
and to show Mark and designate  
the said Corner with a permanent  
Monument of Stone.

It is further ordered and decreed that  
as soon as the said N. E. is established  
as hereinbefore required the said John  
P. Dix Esq<sup>r</sup> Surveyor of Suval Co shall  
proceed to run in Cooperation with  
the authorized Surveyor or Commissioners  
of Puceos Co, or alone, the Eastern  
Boundary line of Suval Co, South to the  
probable South Boundary line of the  
said Counties, and that if the North

Boundary line is not run in the  
Establishment of the aforesaid N.E.  
Corners of Duval Co, then the Surveyor  
of Duval Co shall proceed to run the  
North Boundary line of the said County  
of Duval, its legal length West and  
establish the true N.W. corner of said  
Duval Co

It is further ordered and decreed that  
the said Surveyor shall await the  
further instructions of this Court before  
running the South & West Boundary  
line of this County,

x And that a Copy of this Decree be  
furnished to the County Surveyor Mr  
John J. Dix for his authority and  
guidance
