The character of country through which the line between Crene & Ward Counties runs is a rolling sand prairie covered with mesquite brush.

To establish the S.E. Cor. of Winkler County, which is also the S.W. Cor. of Ector County, we began at the N.E. ## REPORT OF SURVEY

Survey of W. line of Ector County, October 27, 1887. A. M. Randolph Deputy surveyor of Reeves Co. A. J. James Deputy surveyor of Midland Co. & W. J. Mosley surveyor of Midland Co. being present and Chester Shear & Robert Lavoy as chairman & J. W. Lawrence flagman, we made the following survey.
