R.R., at 1 mile set stone, at 1 mile and 24 vs. cross Snake Creek, at 1 mile and 69 vs. recross same, at 1 mile and 83 1/2 vs. recross same, at 2-miles set stone, at 2 miles 1185 vs. cross center of T.W.
