Dear Sir:- Replying to yours of the 31st ult;- enclosing connecting line and list of surveys near to and on the boundary line that separates the county of Galveston from the county of Brazoria and in the list of surveys the area of each survey is given to which the respective counties are entitled, has been examined, but cannot be approved for the reason that the connecting line was not accompanied by a sketch of the surveys named, with the county boundary delineated thereon, and giving the course and distance from the corners of each survey through which said boundary passes, therefore the abstract cannot be corrected in compliance with the requirements of the statutes until the sketch with county boundary delineated thereon, has been filed in this department.

The county courts, instead of the Commissioners' Courts have the authority for making the required orders for the permanent establishment of county boundaries.

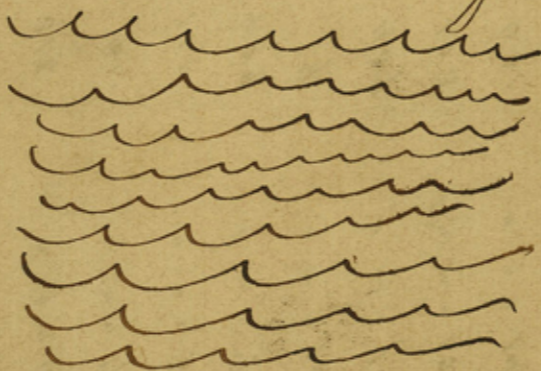
