TO THE HONORABLE C.W.KING, JUDGE OF SAID COURT:

YOUR PETITIONER, Jot Horton, acting herein and at the request of the Commissioners Court of Hansford County, Texas, respectively, represents and shows to the Court that the west boundary line of said Hansford County, Texas, that is, the boundary line bounding said County on the west die is not sufficiently and well defened, and the line and corners thereof of said county are not established as provided by law; and that it isto the best interests of said Hansford County, Texas, and the taxpayers thereof, that said west boundary line of said county, be immediately established and made sufficiently definite and well defined in order that said Hansford County, and the tax payers thereof, may receive the benfit of the taxes on all property lying within the lines of said County as provided by law, and your petitioner alleges said Hansford County is now not, and has not been for many years pasr receiving proper teaxes on a graat many acres of ground properly lying within the limits of said County, lying along, near and adjacent to said west boundary line, and in support of such allegation, ypur petitioner would respectively represent and show to the court that said west boundary line has never been run by a competent surveyor for the purpose of establishing, and fefinintley fixing and defining same, but that numerous surveys have bane made of parts of said

line,and of the blocks and surveys adjoining and crossing same, and that according to all of said surveys the west boundary line of said county runs west of the following sections or suveys in Block Two (2), G.H & H. R.R.Co., land in Hansford County; Surveys Nos, 49, 50, 51, 52, 5 3, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64, 65, 66,67, 68, 69,70, 71 and 78, said and a part of the following sections and surveys in/Block are in Hansford County; Sections or Surveys, Nos, 2, 5, 26, 27, 28,29, 30,31,32, 33, 34, 65, 36, 37, 38, 39, 40, 41, 42, 43, 44, 45, 46, 47,48.

Your Petitioner would further represent and show to the Court that according to the abstracts of the surveys of land furnished to the Tas Assessor of Hansford County, Bythe, Land Commissioner none of the Sections named last/above are within the limits of Hansford County, and only a part of the surveys and sections first named above are within the limits of Hansford County, and that by reason thereof, Hansford County, is not now, and has not been receiving taxes on a great many acres of land in the above mentioned surveys which are within the limits and boundaies of Hansford County,

WHEREFORE, premises considered, your petitioner prays that an order be entered by this Court that the W st boundary of said County is not suffictently and well defined and definite, and that this Court appoint and experienced and competent practical surveyor to ascertain by actual survey the said West boundary line of said County, and to make and establish the lines and corners as provided by law, and fixing a time and place when and where said surveyor shall make said survey, as provided by law, that notice issue to the County Court of Sherman County, Texas, as provided by law. THE STATE OF TEXAS IN THE COUNTY COURT OF COUNTY OF HANSFORD IN THE COUNTY, TEXAS.

On this, the 18th day of June, A.D.1927, came on or be heard and considered by the Court the matter of the petition of Jot Horton, acting for and at the request of the Commissioners Cpurt of Hansford County, Texas, for the establishment according to law of the West Boundary line of said County, and it appearing to the Court, after reading said petition, and the facts introduced in evidence thereupon, that said petition should in all things be granted;

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, by the Courtthat said petition shall be, and is hereby in all things granted, and a survey is hereby ordered to be made and the west boundary line of said Hansford County established and made sufficiently definite and well defined as provided by law, and the initial corners of said survey shall be designated by post, mounds or stones monuments in the manner and form and of the material provided for by law, as well as the posts at the end of each mile in said boundary line shall be placed thereat in like manner as provided by law, and the Surveyor herein appointed shall make a plat and field notes thereof, and property show thereon all such corners and posts, as well as an accurate description of all prominent natural objects crossed by or adjacent to said line, as well as of the corners and lines of surveys on or near said boundaries, all of which shall conform to the law defining the boundaries of said county, and that when said line shall have been durveyed and marked as herein provided, that said Surveyor shall make due return of said field notes and map to this court, which shall be recorded by the Clerk of this Court, and a certified copy thereof returned to the general land office, and said survey, before entering upon the duties herein prescribed, shall take the oath of Office, prescribed by law for County Surveyors, and enter into bond in the sum of One Thousand Dollars, with two or more sureties to be approved by the County Judge, of Hansford County, payable to the County Judge or his successors in office, conditioned for the faithful performance of his duty as provided by law.

It appearing to the court that T.O. James, is an experienced and competentpractical surveyor, the said T.O. James, is hereby appointed as the Surveyor to run the lines and definitelyfix and define the west boundary line of said county, as herein provided, and said Surveyor shall begin the work thereof at 9;00 o'clock on the morning of September 12th, 1927, and shall begin at the northwest corner of said county of Hansford, and run, west boundary line thereof South to the Southwest corner aso the herein provided, and a copy of this order, together with proper notice shall be sent to the County Court of Sherman County, being the other interested County in such boundary line, which notice shall state the time and place when and where said survey will be commenced, as provided by law.
