On this, the 10th day of September, A. D. 1928, came on to be heard and considered by the Court the matter of the approval of the return, report, field notes and map of T. O. James, the Surveyor who was appointed by this Court on the 18th day of June, A. D. 1927 to ascertain by actual survey the west boundary line of Hansford County, which is also the east boundary line of Sherman County, and to make and establish the lines and corners and mark the same, and to make proper return and report to this court of the field notes and map, and of all of his actions in connection therewith as provided by law, and it appearing to the court that at the time this court made and entered said order appointing the said T. O. James as such surveyor to make and run said west boundary line of said Hansford County as set out in said order, that this court was at said time satisfied, and it appeared to the satisfaction of this court, that said boundary line was not sufficiently definite and well defined; and it further appearing to the court that the said T. O. James has complied with all of the orders of this court; that the said T. O. James is an experienced, competent practical surveyor, and is a State Licensed Land Surveyor, and has made his return and report to this court as provided by law; and that the said T. O. James has run said west boundary line of Hansford County, which is also the east boundary line of Sherman County and has ascertained by actual survey said boundary line, and has established the line and corners and marked said boundary as provided by law, and has made a map of said line and field notes thereof, and has made return and report of his actions to this court as provided by law; and that the said T. O. James has entered into bond as provided by law; and it further appearing to the court that <sup>proper notice of</sup> the appointing of said surveyor for said purpose

was served upon the County Court of Sherman County, said notice having been served upon said the County Court of Sherman County on the 22nd day of August, A. D. 1927, and that said County Court of Sherman County sits in regular session, and the next term of said court after said 22nd day of August began on the first Monday in September, A. D. 1927, <sup>being the 5th day of September of said year,</sup> and that said notice was served upon said County Court of Sherman County for more than ten days before the meeting of said court; and that this court fixed the time and place for said surveyor to meet a surveyor appointed by the County Court of Sherman County to run said boundary line, said time being the 12th day of September, A. D. 1927, which was <sup>not</sup> more than twenty days after said County Court of Sherman County met; and that the said T. O. James was at the place and at the time fixed by this court to run said boundary line, and that at said time the said T. O. James did meet D. D. Spurlock, the County Surveyor of Sherman County, who was appointed by the County Court of Sherman County to meet the said T. O. James at said time and place for such purpose, and it further appearing that the said D. D. Spurlock was accompanied by the Honorable F. B. Mullins, County Judge of Sherman County at said time, and both the said D. D. Spurlock and the said F. B. Mullins, County Surveyor and County Judge respectively of said Sherman County witnessed and assisted in the commencement of the running of said boundary line, but that the said D. D. Spurlock did not continue with the work of assisting in running said boundary line, but that the same was run by the said T. O. James alone, and it appearing to the court that the said T. O. James has in all respects complied with the law in connection therewith:

IT IS THEREFORE ORDERED, ADJUDGED and DECREED by the Court that said return and report of the said T. O. James, and the field notes and map prepared by him be, and the same is hereby approved, and said return, report, field notes and map are hereby ordered recorded, and said line so



run is hereby declared to be the west boundary line of  
Hansford County and the east boundary line of Sherman County,  
as provided by law, and the Clerk of this Court is hereby  
ordered to send a certified copy of same to the Commissioner  
of the General Land Office at Austin, Texas, <sup>for his approval</sup> as required by  
law.




