day of August, 1843.

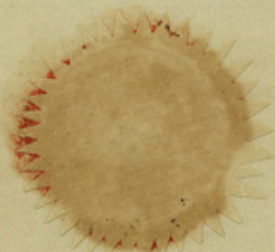
