TO THE HONORABLE COMMISSIONERS COURT OF ANDERSON COUNTY, TEXAS:

WHEREAS, on the 14th day of December, A. D. 1936, the Commissioners Court of Anderson County, Texas, made and passed the following order, to-wit:

"THE STATE OF TEXAS OUNTY OF ANDERSON

"On this the 14 day of December, A. D. 1936, the Commissioners Court of Anderson County, Texas, convened in session at the regular meeting place thereof with the following present, to-wit:

J. C. Harding
Commissioner, Precinct No. 1
Edd O. Lively
Commissioner, Precinct No. 2
M. A. Cook
Commissioner, Precinct No. 3
J. W. Isabell
Commissioner, Precinct No. 4

and among other proceedings had were the following:

"Commissioner J. C. Harding introduced a proposed order which was read in full, and after the same was read said Commissioner made a motion that the order be passed and adopted. Said motion was seconded by Commissioner M. A. Cook, was voted on and was carried by a unanimous vote. Thereupon the County Judge announced that said order had been passed; the same being in words and figures as follows, to-wit:

"AN ORDER TO RETRACE THE NORTHERN BOUNDARY LINE OF ANDERSON COUNTY AND PLACE ADDITIONAL MARKERS THEREON.

"WHEREAS, in the year 1848, D. H. Edens, in pursuance of an order of the County Court of Anderson County, Texas, ran the Northern boundary line of said county, beginning at the Northeast corner of the John Ferguson League on the West bank of the Neches River, and from thence in a Westerly direction to the Northwest corner of Anderson County on the East bank of the Trinity River, and in his report of said survey he stated that from the beginning point at the Northeast corner of the said John Ferguson League he ran a course South 80° 50' West, and that he plainly marked the line so run on line trees at a distance of one mile apart on the whole length of the line except at the end of the ninth mile which was in the Caddo Marsh; and,

"WHEREAS, the said D. H. Edens reported his action to the County Court of Anderson County and the same was duly filed and placed of record in the minutes of said court; and,

"WHEREAS, in pursuance of an order of the County Court of Henderson County made and entered in the year A. D. 1890, J. T. Meredith, County Surveyor of said County, ran the Northern line of Anderson County beginning at the Northwest corner of Anderson County and thence on a course North 81° 20' East to the northeast corner of Anderson County, the same being the Northeast corner of the John Ferguson League on the West bank of the Neches River, and that the line so run by the said Meredith on the course North 81° 20' East coincided with the line theretofore run by D. H. Edens in the year 1848, although the said Edens reported that the course of the line run by him was slightly different from the course of the line which the said Meredith found on the ground; and,

"WHEREAS, Anderson County has at all times recognized and treated as the North boundary line of Anderson County a line running from the Northeast corner of the John Ferguson League on the Neches River on a course South 81° 20' West as the same was actually run on the ground by the said Meredith and Edens, and it is considered that such line is sufficiently definite and well defined and that the Commissioners Court of this County has no power to enter an order having an actual survey made of said boundary and to make and establish the lines and corners of said Northern boundary, for the reason that the same have been definitely fixed, established and defined by the survey of Edens and the survey of Meredith as aforesaid. But it is the opinion of this Court that it would be advisable to have said Northern boundary line investigated for the purpose of determining whether any of the markers or monuments placed thereon by the said Meredith have disappeared and if so to have other and permanent markers made:

"THEREFORE, BE IT ORDERED BY THE COMMISSIONERS COURT OF ANDERSON COUNTY, TEXAS, that W. B. Chambers, County Surveyor of said County be, and he is hereby, authorized to investigate and retrace said boundary line as the same was run and marked by the said J. T. Meredith beginning at the Northeast corner of the John Ferguson League on the West bank of the Neches River in said County following the old line fixed and marked on the ground by the said Meredith and placing additional suitable permanent markers or monuments on any part of said line where the same is necessary, either by reason of the disappearance of the original markers or monuments, or by indistinctness or any other insufficiency. But no authority is herein granted to the said W. B. Chambers to define or establish a new boundary line nor to do anything other than to retrace and remark said Northern boundary of Anderson County as the same has been heretofore actually defined, located and established on the ground by the other surveyors aforesaid." And,

WHEREAS, the Commissioners Court of Henderson County, Texas did thereafter make and pass an order similar to the foregoing order of the Commissioners Court of Anderson County, Texas, and in said order did appoint Mr. B. H. Wathen, County Surveyor of Henderson County, Texas, an experienced and competent surveyor, authorizing and directing him to report to the place named in said orders as the place of beginning and at a time convenient to the said W. B. Chambers

and B. H. Wathen, and to assist in running, retracing and marking the common boundary line of said two counties, being the North boundary line of Anderson County and the South boundary line of Henderson County, and to place additional suitable permanent markers or monuments of such character and at such places on said line as are required by law, and said surveyors so appointed having accepted said appointment and having completed said work in accordance with the orders of said respective Commissioners Courts, we beg leave to, and do herewith file, a report of the work done, together with field notes and map.

That at a date subsequent to the respective orders of said Courts said surveyors, the surveyors so appointed, the undersigned, proceeded to the Northeast corner of Anderson County and the Southeast corner of Henderson County, said point being a common point and located at the Northeast corner of the John Ferguson League on the West bank of the Neches River, the same having been fixed as the Northeast corner of said Anderson County by an Act of the First Legislature of the State of Texas approved March 24th, A. D. 1846, and said point having been located and established as the Northeast corner of said Anderson County by D. H. Edens, surveyor appointed by the County Court of Anderson County to fix and establish said line, and the same was afterwards, on the 21st day of June, A. D. 1890, found and recognized as the Northeast corner of said Anderson County by J. T. Meredith, County Surveyor of said Henderson County, on an official survey pursuant to an order of the County Court of said Henderson County, and from said beginning point we investigated, found, surveyed, and retraced said boundary line as the same was run and marked by the said J. T. Meredith in 1890 throughout its whole course to the Northwest corner of said Anderson County and the Southwest corner of said

Henderson County to a point on the East bank of the Trinity River, which said last mentioned point was fixed as the Northwest corner of said Anderson County by the Act of the First Legislature of the State of Texas approved March 24th, A. D. 1846, and which was located and established by said Edens and ascertained and found and marked by the said Meredith on his survey as aforesaid, and we placed a concrete monument at said Northeast corner of said County and a concrete monument at said Northwest corner of said County, and we placed concrete monuments at intervals of one mile throughout the whole course of said boundary line because, although said boundary line could be clearly traced and followed by reason of the marks made by the said Meredith and from recorded data, we nevertheless found that the permanent monuments at intervals of one mile which had been erected and placed on prior surveys of said line had disappeared. That we finished the field work of said survey on the 14th day of May, A. D. 1937, and we finished establishing the concrete monuments on August 25th, A.D. 1937, and having drafted the field notes and the map of said survey, we herewith return the same to the Honorable County Court of said County and certify the same to be as follows:

BEGINNING at the N E corner of Anderson County and the S E corner of Henderson County, Texas, and at the N E corner of the John Ferguson League on the West bank of the Neches River where we found the old 30 in. Pin Oak, mkd.  $\overline{X}$ , (old), bearing S 14 W 9.6 vrs, and a large pine stump bearing S  $33\frac{1}{2}$  W 9.4 vrs, being record trees for said survey corner; we also marked a 14 in. Elm bears S 47 W  $28\frac{1}{2}$  vrs, a 14 in. P. O. brs. S. 33-3/4 W 31 vrs, both mkd X, two hacks above and three below, a concrete monument brs S 80 deg 54' W 10 vrs;

THENCE S 80 deg 54 Min. W (retracing old county line as marked)
1900.8 vrs to the first mile post, a concrete monument for corner in an open field;

THENCE continuing S 80 deg 54 min W 1900.8 vrs to the second concrete mile post in field whence the N W corner of Joe Gillespie's 341 acre tract brs N 48 W 118 vrs;

THENCE continuing S 80 deg 54 min W 1900.8 vrs to the third mile post in Boyd Bacon's field, being 20 vrs E of the West line of his 70 acre tract;

THENCE S 81 deg 15 min W (retracing old county line), at 223 vrs a rock pile at the S E corner of the Isaac Ledbetter Survey, at 1257 vrs, the E B L of the Alfred Benge Survey (League), at 1900.8 vrs, the seventh mile post on E bank of drain, whence a 6 in. Elm brs S 66 E 12 vrs, a 12 in Sweet Gum brs N 34 E 12.6 vrs;

Commissioner J. C. Harding introduced a resolution and moved its adoption and the motion was seconded by Commissioner Elvis Gilmore. The motion carrying with it the adoption of the resolution carried by unanimous vote. The resolution is as follows:

## RESOLUTION

WHEREAS, on the 14th day of December, A. D. 1936, the Commissioners Court of Anderson County passed an order to retrace the Northern boundary line of Anderson County and place additional markers thereon, and ordered W. B. Chambers, County Surveyor, to investigate and retrace said boundary line as the same was run and marked by J. T. Meredith beginning at the Northeast corner of the John Ferguson League on the West bank of

the Neches River and following the old line fixed and marked on the ground by Meredith, and to place thereon additional suitable permanent markers or monuments where the same are necessary; and the Commissioners Court of Henderson County, Texas, did thereafter make and pass an order similar to the said order of the Commissioners Court of said Anderson County, and in said order did appoint Mr. B. H. Wathen, County Surveyor of said Henderson County, and authorized and directed him to proceed to the place named in said orders as the place of beginning and to assist the said Chambers in running, retracing and marking the said common boundary line of said two counties; and,

WHEREAS, the said two surveyors have completed the work in accordance with the orders of the respective commissioners courts, and have made and filed with the County Court a sworn report of their work, together with the field notes and map of the line surveyed, under date the 14th day of September, A. D. 1937, and said return and report have been examined by the Court:

BE IT RESOLVED BY THE COMMISSIONERS COURT OF ANDERSON COUNTY, TEXAS, that said report and return of the field notes and map be and the same is hereby in all things fully approved, and that the line therein defined is and shall be the common boundary line between said two counties.
