A a Coll session of the County Court of
 Anderson County held at Palestine on the
 3 of October A D 1848. The following among
 other proceedings were had,

The State of Texas }
 County of Anderson } To the Honorable County
 Court of Anderson County, pursuant to an
 order issued to me from said Court, passed at
 the July Term 1848 and said order having
 been amended at the August Term 1848. of
 said Court appointing me to run the Northern
 Boundary line of said County of Anderson.

I went to the place of beginning (at the NE Corner
 of John Furgersons League, on the 15th day of
 September, the day named in said order and not
 having been met by a surveyor from Henderson
 or Van Zandt County I proceeded to run and
 mark said Line Beginning at the above named
 North East Corner of John Furgersons League on
 the West Bank of the Neches River by a
 Iron wood or Horn Beam 7 inches in diameter
 marked A C Thence S 80° 50" West at 9 miles
 Cross Caddo Creek 20 miles 1140 Varas To the
 East Boundary Line of Henderson County at 35
 Miles 373 Varas Crossed Cat fish Bayou thirty six
 (36) miles 884 Varas To the East Bank of the
 Trinity River a Hackberry for a corner 13 1/2
 inches in diameter marked A C L 36 1/2 M

From which are ash 20 in di marked
A C bears ~~South~~ S 89 E 7/4 Varas Varas distant
and another ash 36 in di marked A C bears
S 41 E 10/4 Varas distant Said Corner the
north West Corner of Anderson is about
3 miles 150 Varas N 52° W of the North West
Corner of R W Bots assignee of James Wilson
survey of Two 2/3 thirds of a League and one
Labor of Land. The line is plainly marked
and each mile tree marked with the letters
A C I and numbered from 1 to 36 M except
the 9th mile which is in the Cuddy marsh
The length of the line from River to River
is Twenty Six miles and 884 Varas.
