the report of David O Norton a citizen of said
County would most respectfully report and show
to your honorable body that in obedience to your
Order made on the 13th day of October AD 1847
and renewed on the 18th day of Sept 1848 your
Reporter proceeded to run and mark the South
boundary line of Hopkins County in accordance
with said Order and which duty being performed
begs leave to present for your acceptance the
following plat and field notes of said survey
and respectfully asking a favorable consideration
further sayeth not, November 20th 1848
