In the matter of the contest between Rockwall and Hunt Counties over the boundary lines between said counties:

(1) We have searched the records and can not find where any boundary line has ever been established and of find, however, that in the year 1880 Sherwood a surveyor of Rockwall in conjunction with the surveyor of Hunt County surveyed a line between said Counties and marked same and made field notes for same attached hereto and marked exhibit "A" and that said lines so surveyed has been recognized by both Hunt and Rockwall Counties as the boundary line between said counties by the tax assessors and collectors of both counties. This line though not in every way logically laid out and established becomes the boundary line between said counties by recognition by interested parties. Sayles Revised Statutes 1897 Art.822.

Now , if this should not be sufficient to establish said boundary line between said counties then we submit the following.

The act of the legislature creating Hunt County begins at the Northeast corner of said county a point well established and about which there is no contention and makes said Hunt County 25 miles East and West.Now Hunt County can not claim nor hold any more territory than amount given it by said acts of Tex. Legislature creating same and we therefore contend that to locate the boundary line between Rockwall and Hunt Counties at its correct place we ought to go to the North East corner of Hint County and run the North line of said Hunt County to the 25th mile post thence South to intersection of North line of Kaufman County and we contend for Rockwall County that this would locate without doubt the said boundary line which could not be incorrect. All Rockwall County wants is that the line be established correctly and definitely. This can be done in this manner without prejudice to either party at either party.

We further most respectfully submit that the South East corner of Rockwall County is now and has been so certainly located that there is no question as to the correctness thereof. See certified copy of records showing said corner to have been legally established by direction of the land Commissioner of Texas by Geo. Truitt surveyor certified copy of his report attached hereto and made a part hereof and marked exhibit "B".

We contend that it would be an easy proposition to begin at this well located corner and run the boundary line in controversy with reasonable cer-

tainty and accuracy.

We respectfully submit these suggestions for your consideration in the hope that these differences may be settled correctly.
