

To the Honorable J. S. McNeill Judge of the
County Court of Jackson County Texas

The undersigned P. P. Putnam County
Surveyor of Jackson County reports:

That in pursuance of an order of the County Court
of said County made at the April Term 1886
That he proceeded at the time and place fixed
by said order to survey establish and mark
the line between Jackson and Lavaca at the
corner common to Jackson and Wharton
Counties on the Lavaca County line and did
meet on the 13th day of July 1886 H. H. Russell
County Surveyor of Lavaca County who with
the undersigned agreed to the Establishment
of said corner and line.

Beginning at a Cypress post 8 inches square
and 5 feet long, set in the ground 3 feet with a
mound around same in prairie. said post
marked on S.E. side and cut in the wood
N cor Jackson Co and on N.W. side LAVACA
and on S.W. side Co LINE from which the 29th
mile post on the Wharton & Jackson Co line
bears S 45° E 788 var - and the Golden Rod
Creek br N 51° E 3303 var and the N.E
course of the Archibald S. White leg
br S 13° E 699 1/2 var

Thence South 51° West (var 9° W)
at 186 var over low wet prairie cross a wire fence
at 797 var set Bois d'arc Post marked miles on N.E. side
and ^{LAVACA} Co on N.W. side and ^{KS} Co on S.E. side
and ^{Co} LINE on S.W. side, said post is 5 feet
long and set 3 feet in the ground with

with a mound around it - This post is numbered from the SE corner of Lavaca Co and only represents 797 varas - On Jackson Co line all posts hereafter mentioned are of same kind and dimensions put in the ground same depth and mkd same with proper miles represented thereon

- at 309 $\frac{1}{2}$ var - Intersect the N Boundary line of a white league 5109 $\frac{1}{2}$ var from its NW corner on Navidad River and 1172 $\frac{1}{2}$ var from its NE cor in prairie, at this point cross R J Clarks wire pasture fence

 Victoria County. From which a Post Oak S. W.
 from the Twin Motts brs N 30° 45' E and a small
 lone Red Oak brs S 80° 45' E, and the E edge of a lone mott
 in a pasture in the Victoria Prairie brs S 19° W.
 The old marked line between Lavaca and Jackson Counties was
 found adopted and retraced which we find to have been irregu-
 larly run at a ver of about 9° 15' E. The above line was
 plainly marked with five (5) marks thus =

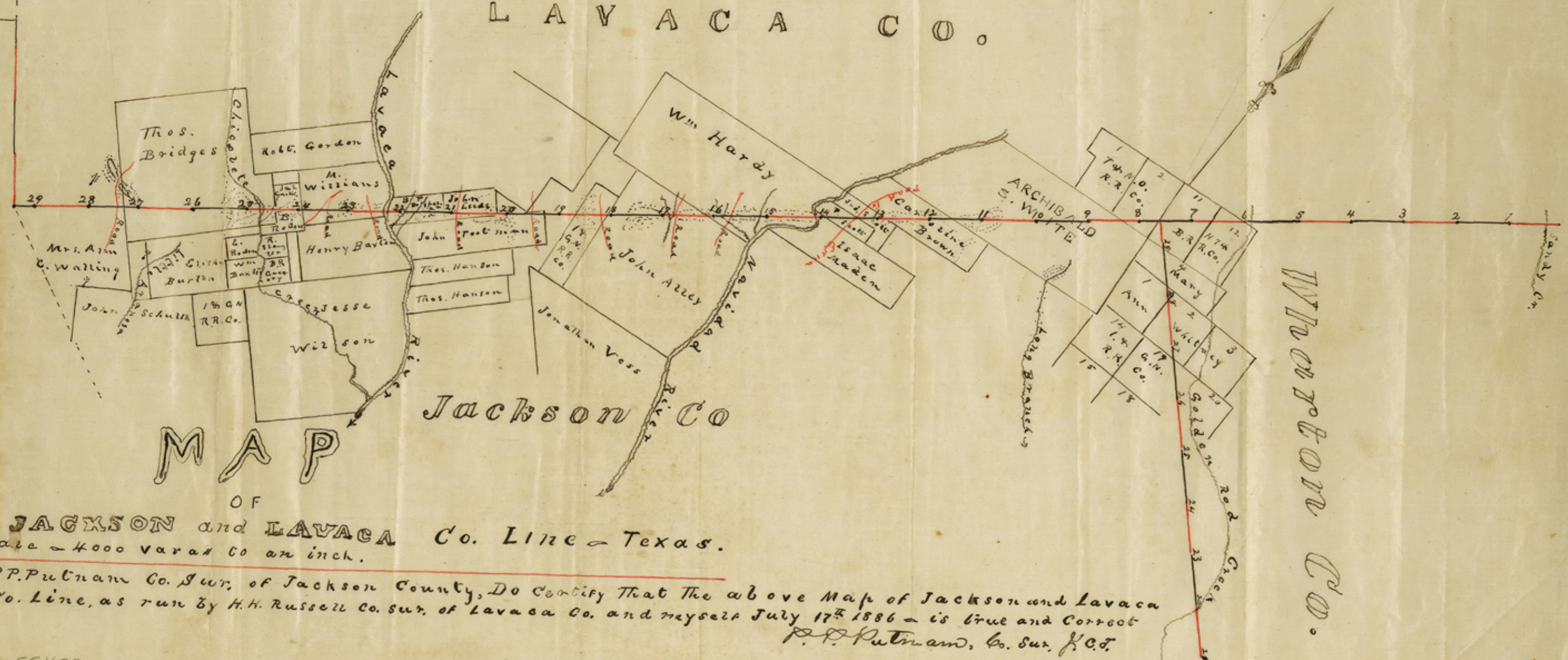

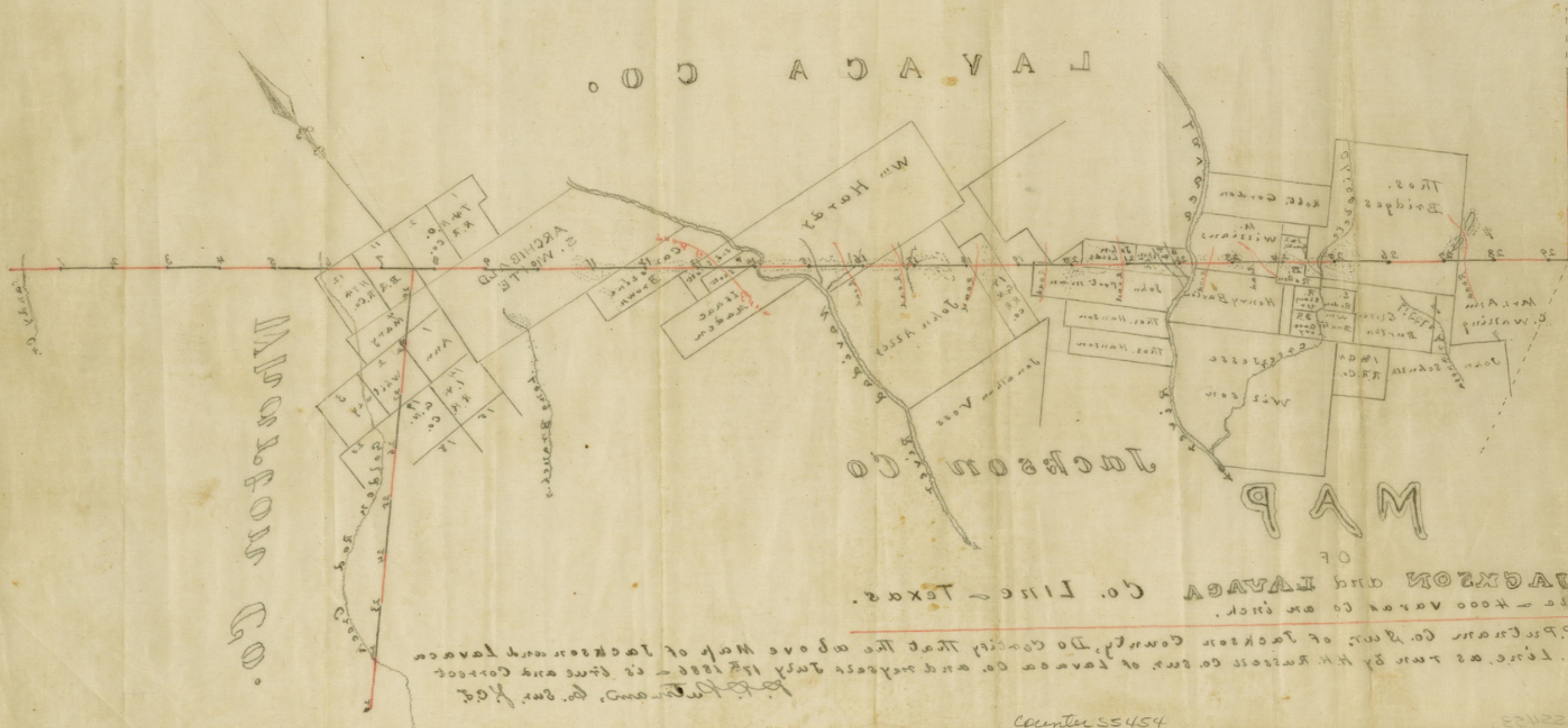
