

TO THE COMMISSIONERS COURT OF JASPER AND NEWTON COUNTIES:

Having been commissioned by Jasper and Newton Counties to run and mark a portion of the County line between said counties, I submit to you the field notes of that portion as follows:

BEGINNING at the Southwest corner of Newton County and the Southeast corner of Jasper County on the North line of Orange County, said beginning point being the Southwest corner of the Jasper Harding Survey, a concrete monument for corner.

THENCE N 3°19'E with said division line between Newton and Jasper Counties at 19+14.74 varas cross the North line of said Harding Survey at a point 149.8 varas N89°17'E of its Northwest corner - at 37+84.79 varas cross the North line of H.T. & B. Section 3 at a point 286.6 varas N 88°35'E from its Northwest corner - at 39+18.99 varas cross the South line of the J. Gist Survey at a point 296.0 varas N 88°35'E from its Southwest corner - at 48+74.01 varas cross the South line of H.T. & B. Section 1 at a point 362.18 varas N 88°04'E from its Southwest corner - at 58+69.61 varas cross the South line of H.T. & B. Section 9 at a point 431.63 varas N 89°16'E from its Southwest corner - at 80+01.26 varas cross the South line of the C. P. Bratnaber Survey at a point 583.92 varas S 83°39'E from its Southwest corner - at 89+79.37 varas cross the South line of the F. M. Davis Survey at a point S 85°18'E from its Southwest corner - at 99+13.04 varas cross the South line of H. & T.B. Section 11 at a point 721.87 varas S 84°09'E from its Southwest corner - at 118+98.80 varas cross the South line of the George W. Smyth Survey at a point 753.8 varas N 89°05'E from its Southwest corner - at 138+50.28 varas cross the South line of the V. Wright Survey at a point 860.45 varas S 88°28'E from its Southwest corner - at 158+01.94 varas the Southeast corner of the J. M. Swisher Survey in Jasper County and the Southwest corner of H.T. & B. Section 1 in Newton County and the end of this project.
