

At a term of the Commissioners Court for the County of Jones and State of Texsa. Began and holden at the Court House in said Jones County, on the 8th. day of June A.D.1891.

Present and presiding the, Hon. C.J.Munroe, County Judge. J.W. Vaughn, Commissioner, Precint No. 1. Ed Kennedy, Commissioner, Precint No. 2. R.D.Jeffries, Commissioner, Precint No.3. William Winter, Commissioner, Precint No. 4. R.V.Colbert, Clerk of said County, and for said Court, and Ed M. Tyson, Sheriff of said County, Court was opened in due form of law, and the following proceedings were had to-wit: J.W.Vaugh presented in open court a certified copy of the proceedings of the Commissioners Court of Shackelford County, Texas, Ordering a survey to be made to determine and establish the West boundary line of said Shackelford County, and it appearing from the field notes accompanying said order that said west boundary line of Shackelford was duly surveyed by W.A.Eaheart, Surveyor which survey was completed on the 19th. day of October A.D.1889. and the field notes and plat of said survey were returned by said W.A.Eaheart to the Commissioners Court of said Shackelford County, and was by said Court accepted and approved and duly recorded in the minutes of said Commissioner's Court of Shackelford County, on pages 92 to95, inclusive in minute book No.3

And it appearing to this Court from said field notes as made by the said W.A.Eaheart. establishing the West boundary line of Shackelford County, that said survey has been correctly made and establishes the East boundary line of Jones County.

It is therefore Ordered, Adjudged and Decreed by this Court that the survey as made by the said W.A.Eaheart, surveyor for Shackelford County, be and the same is hereby accepted and in all things approved as correctly establishing the East boundary line of the said Jones County, Texas, and it is further ordered that a certified copy of all the orders and proceedings had by said Commissioner's Court of Shackel-

ford County appertaining to said survey together with field notes of said survey be duly recorded in the minutes of this Court, and that the Clerk of this Court transmit by mail a certified copy of this order together with order of Com. Court of Shackelford Co. to the Commissioner of the General land office.
