IN THE MATTER OF COMAL AND KENDALL COUNTY LINE IN COMMISSIONERS' COURT OF COMAL COUNTY, TEXAS. APRIL REGULAR TERM, A. D. 1929.

On this the 8th day of April, A. D. 1929, came on for consideration the report of Alfred R. Rothe, Surveyor, and Frank Nowlin, County Surveyor of Kendall County, Texas, regarding the County Line of Comal and Kendall County recently surveyed by said parties, and after due examination and consideration of said report by the Court, the same be and is hereby approved and further ordered that said report be entered in the Minutes of the Commissioners' Court. Said report is in words and figures as follows:

To the Honorable Commissioners Court of Comal and Kendall County, Texas. In compliance with an order passed by the Commissioners Courts of Comal and Aendall County, Texas, to resurvey the common boundary of Comal and Kendall Counties from the common corner of Kendall. Comal and Bexar Counties in middle bed of Cibolo at mouth of Balcones Creek to the mouth of Curry's Creek, a recognized point on the commong boundary of Comal and Kendall County, we Frank Nowlin, County urveyor of Kendall County, "exas, and Alfred R. Rothe, a surveyor of Comal County, especially appointed by the Com. Court of Comal County for this work, met, as agreed, on the premises of Paul Richter on the morning of Dec. 14th 1928. Mr. Richter showed us some Live Oak trees marked with five hacks in his pasture for County line marks and as they were standing to each other in a direction we thought said County line will run, we decided to run a random line from said point towards Curry's Creek and by running a line N. 47-43! E. (Var. 9-45' E.) 3160 vrs. we exactly hit the mounth of said creek, the point we wanted to get to. By starting at the same point in Richter's pasture we ran S. 47-43' W., the same course reversed, towards Balcones Creek and came out at a point 509 vrs. N. 42-17' W. from the common corner of said two counties. We made a calculation of the true course of said County line and found said line running N. 46-37' E. (Var. 9-45' E.) a distance of

13.92 miles, from mouth of Balcones Creek to mouth of Curry's Creek. We had by running our random line established rock piles at each mile and also raised rockpiles wherever we crossed the County Roads, and also ran connection lines wherever possible to known original corners of surveys traversed, so in going back we all placed said marked and rockpiles at their proper places on said true line.

Hereby annexed we submit field notes of said line and also sheet showing the distribution of the acreage of all surveys traversed by said line among the two counties.

We employed in carrying out the work five men, viz: two axmen, two chainmen and one flagman.
