Pursuant to the order of Lamb County to survey, establish, and fix the north boundary of Lamb County, said order being dated Feburary 8, 1916. I W. J. Williams, a practical surveyor, duly appointed and fully qualified as special surveyor for Castro Co. as required by law, was at the N.W. corner of Hale County, same being the N.E. corner of Lamb County in the south line of Castro County on the 14th day of March 1916, that being the place and time designated in said order. No other party or surveyor being present I adjourned the meeting to confer and arrange with W. D. Twichell, he being the qualified surveyor for Lamb County, and on March 30, 1916 W.D. Twichell and I jointly begin the survey of the boundary between Lamb and Castro Counties as follows:-


