

To the Hon. Hall, Land Commissioner of
the State of Texas.

Your petitioner the County of Webb by her
Attorneys Dorr & Pierce, by to make this
formal protest against the adoption of any
survey of the South boundary line of LaSalle
County, made in pursuance of an order
of the Commissioners Court of LaSalle County
passed November 9th 1886. Directing one
Thomas Prandy County Surveyor of LaSalle
County to make said survey in accord-
ance with said order, beginning on December
6th and concluding said survey on December
12th 1886. And for cause show.

First! That a copy of said order with precept
for service was made Nov. 27th 1886. And was not
served upon J. M. Rodriguez County Judge of
Webb County, the County to which Incinal
County is attached for judicial purposes
till November 29th 1886. And only seven
days prior to the date upon which said
Surveyor was to begin to survey and ~~mark~~^{mark}
said boundary. And that therefore any survey
made is without authority of Law, is null
and void. See R.S. 687.

Second. Because said Southern boundary
line of LaSalle County, was in accordance
with the provisions of Chapter four Title
21 Revised Statutes of Texas, and ⁱⁿ accordance
with an order of the Commissioners Court
of LaSalle County, duly served upon the
County Judge of Webb County, the County

1 to which Decinal was then & is now attached
2 for judicial purposes, wrapped and the said
3 boundary specified and marked by the person
4 designated by said order of the Commissioners
5 Court of said LaSalle County, which field
6 notes defining & marking said boundary so made
7 by the person thus designated by the Commissioners
8 aforesaid, was at a regular meeting of the
9 Commissioners Court of said LaSalle County
10 ratified confirmed and adopted on November
11 14th 1881.

12 Thirdly Because the adoption of the survey
13 field notes & marking and defining the
14 said boundary in 1881, in accordance with
15 Chapter 4. Title 21 Revised Statutes of Texas
16 and the acquiescence of the other Counties
17 interested therein, stops the County of
18 LaSalle from changing altering or amending
19 said boundary line.

20 Fourthly. Said line so made in 1881, has
21 been & is now the recognized boundary
22 between said LaSalle & Decinal, & is so
23 recognized by our Courts as the proper
24 political division of said Counties.

26 Therefore the County of Webb to which Decinal
27 is attached respectfully enters her protest
28 against any change or alteration of said
29 line.
