Standifer, further agrees to start at some well defined point as directed, by the General Land Commissionersof Texas, that has been approved by that department, and it to erect monument of stone or cement post 21 feet long and 8 inches wide and 3 inches thick and wwell marked showing no. of miles on said county line, and the field notes of surveys that the said county line passes through giving survey nos, and blockos, of said surveys and showing the exact no of acres of each survey that the said line passes through belonging to LYNN County or to adjoining counties, and to gives bond of One Thousand Dollars (\$1000.00) payable to the County Judge of LYNN County and his successors in offfice conditioned for the faithful performance of his duties as required by law.

And it is agreed by the party of the second to pay the said w.R.

Standifer the sum of (\$500.00) Five Hundred Dollars, conditioned,
as follows 60% or \$500.00 due when the said party of the first

part has completed his survey of said line heretofore mentioned and
when he has furnished the filed notes and maps and has filed the same with
the County Clerk of said county, and 40 % or \$200.00 when the copy
of the field notes and map has been sent to the General Land office
and has been approved by that department as correct. Witness our
