

THE EAST BOUNDARY LINE OF LYNN COUNTY:

The N.E. Cor. of LYNN County and N.W. Cor of Garza County is large stone marked N.E. L.Co, N.W, G. Co, and is 1666 varas west of East line of no.9, Blk. 24, and 835 varas East of west line of same and 878 varas south of North line of S. and 1023 varas north of south, south line of said No.9, 193, acres in Garza County, 151 acres in LYNN County, 130 acres in LUbbock County and 166 in Crosby County, said stone is 30 miles west of a large set stone in valley of white river an old stone house of ancient architect brs.no.40 east about 400 varas established for N.W. cor.. of Kent County and S.W. cor of Dickens County.
