FIELD NOTES OF BOUNDARY LINES OF MIDLAND COUNTY.

\* BY virture of an order issued by the County Court of Midland County, Texas, a certified copy of which is attached hereto and made a part hereof and under instructions from the Commissioner of the General Land Office, I, Robt. E. Estes, County Surveyor of Midland County, Texas in company with C. B. Collard, Co nty Surveyor, Ector County, Texas, Proceed to the N. W. corner or Coke County to begin the survey for the location of the Midland County boundaries, this being the nearest established corner from which the lines of Midland County could be located. In obedience to the above order and instructions we made the survey described and set forth in the following field notes and accomp.:-

ing to the Court that it will be to the best interest of the county to have said county boundaries surveyed and established at once, it is therefore ordered adjudged and decreed by the Court that h. E. Estes, the County Surveyor of Midland County, Texas, be, and is hereby appointed to survey and establish the boundary lines of midland County; and it further appearing to the Court from instructions received from the Commissioner of the General Land Office, that the North-west corner of Coke County is the nearest established corner to ... Mialand County, it is ordered that said surveyor commence at said North-west corner of Coke county, and run due west 56 miles and there establish the north-east corner of Midland County thus established to run east, south, west and north lines of midland County in accordance with the act creating --idland County. (Acts of 19th Legislature, page 25), and that in establishing the initial corners and the lines of said county he shall comply strictly with Article 800 and 801, Sayles Revised Statutes, 1897. And it further appearing to the Court that the counties of Glasscock and Ector will be affected by the survey of Midland County, it is further ordered that a copy of this order be sent to the County Courts of each of said counties, that they may appoint surveyors to assist in running said lines, if they so desire. Said counties are hereby notified that they will be required to pay their prorata of the expense of surveying and marking the dividing lines between them and midland County, according to Article 807, Sayles hevised Statutes 1897, and said surveyor will commence the survey of said county lines on Monday October 14th, 1901.
