County of Mills. of Mills County, Texas.

The undersigned respectfully represents to your honorable court, that in obedience to an order of your court, that he repaired, on the 18th day of April 1898, to the point designated by the court in said order, made on the 12th day of Feb. 1898 to the South East corner of the E. Yborbo survey on the line of Mills and Brown County, as the beginning point from which to run and establish the boundary line between Mills, Brown, Comanche Hamilton and Lampasas Counties Respectively. That he was not met on that day by any one representing said Counties or either of them - That he proceeded to run and mark out said line in conformity with said order. That on the 19th day of April 1898, he was met by W. J. Soxton of Hamilton at the South East corner of Brown County - and on the 20th day of April 1898 was met by J. A. Chamberlain representing Lampas County about 4 miles East of the S. West corner of Comanche County and in company with said Chamberlain proceeded with said line as follows:

Beginning in South line of E. Yborbo Sur. 1550 vrs. west of its South East corner a st. mound 36 inches in diameter and 30 inches high for North corner of Mills County. a P.O. marked B. S. 76 N. 9 vrs. a Do marked M. brs S. 27 E. 41 vrs. Thence N. 82° E. 325 vrs. crossed a branch of Blanket Creek at 1556 vrs. crossed the East line of said Yborbo Survey 218 vrs north of its S.E. corner at 1760 vrs. end of the 22^d mile. Thence N. 82° E. at 1900 vrs. end of the 23^d mile. Thence N. 82° E. 614 vrs. crossed the East line of the S. K. Blisk survey 590 vrs North of its S.E. corner and at 750 vrs enter Mountain and at 1900 vrs end of the 24th mile on Mountain. Thence N. 82° E. 900 vrs. leave Mountain 1382 vrs cross the E. line of Sec. 42 E. J. Ry. Co. 424 vrs. South of its N. W. cor and at 1900 vrs. end of 25th mile. Thence N. 82° E. 1659 vrs. crossed the East line of Sec 41 E. J. Ry. Co. 132 vrs South of its N. E. corner and at 1900 vrs. end of the 26th mile at foot of Spur of Mountain. Thence N. 82° E. 600 vrs. foot of mountain

on East side of same at 711 vrs crossed the S. line of the J. H. Cox survey 558 vrs. west of its S.E. corner and at 940 vrs. the west line of Comanche County a large Stone Mound for S.W. Cor. of said Comanche County from which the S.E. corner of the J. H. Cox survey lies South 17 vrs. and East 440. Thence N. 82° E. at 444 vrs cross the East line of said Cox Survey 79 vrs. North of its S.E. corner at 960 vrs. end of the 27th mile Thence N. 82° E. 1900 vrs. end of the 28th mile: Thence N. 82° E. at 56 vrs. cross Pompey Creek and at 1620 vrs crosses the East line of the James George Survey 21 vrs. South of its N.E. corner and at 1900 vrs. end of the 29th mile: Thence N. 82° E. at 130 vrs crossed the South line of Sec. 23. E. T. Ry. Co 599 vrs. N. 71° W. from its S.E. corner and at 802 vrs crossed the East line of said Sec. 23 E. T. Ry. Co, 276 vrs. N. 19° E. from its S.E. corner and at 1000 vrs. enter Mountain and at 1900 vrs. end of the 30th mile on Mountain. Thence N. 82° E. at 1035 vrs. crosses East line of Sec 24. E. T. Ry Co 656. vrs. S 19° W. from its N.E. corner 1650 vrs. leave Mountain and at 1900 vrs. end of the 31st mile: Thence N. 82° E. at 582 vrs. crosses South line of Sec. 18 E. T. Ry Co 614 vrs. N. 71° W. from its S. E. corner and 1260 vrs. crosses the E. line of Sec. 18. E. T. Ry. Co, 317 vrs N. 19° E. from its S.E. corner and at 1900 vrs end of the 32^d mile on point of Mountain Thence N. 82° E. at 1502 vrs. crosses the East line of Sec. 19 E. T. Ry. Co, 615 vrs. S. 19° W. from its N.E. cor. and at 1900 vrs. end of the 33^d mile at foot of Potatoe Hill Mountain and on west side thereof.

Thence N. 82° E. at 959 vrs. crossed the North line of Sec. 20 E. T. Ry. Co, on the East point of Potatoe Hill Mountain and 692 vrs. N. 71° W. from the N.W. corner of said Section 20 and at 1739 vrs crossed the E. line of sec. 11 E. T. Ry. Co, 352 vrs. N. 19° E. from its S.E. corner and at 1755 vrs crosses Mountain Creek and at 1900 vrs. end of the 34th mile Thence N. 82° E. 1900 vrs. end of the 35th mile: Thence N. 82° E. 69 vrs crossed the East line of Sec. 10. E. T. Ry. Co, 580 vrs. S. 19° W. from its N.E. corner. and at 1669 vrs crossed the East line of Sec. 9 E. T. Ry Co. 491 vrs. S. 19° W. from its N.E. corner and at 1900 vrs. end of the 36th mile.

Thence N. 82° E. at 852 vrs. crossed the north line of Sec. 8. E. T. Ry. Co, 461 vrs. N. 71° W. from its N. E. corner and at 860 vrs crossed East branch of Mountain Creek and at 1465 vrs. the N. E. corner of Mills County on Sec. 7 E. T. Ry. Co, a Stone Mound 36 in. in diameter and 30 inches high for corner from which the N. E. cor. of Sec 8. E. T. Ry. Co. vrs S. 19° W. 324 vrs and N. 71° W. 175 vrs. Thence S. 30° E. at 343 vrs end of the 37th mile Thence S. 30° E. at 944 vrs. crossed the north line of the Amos Pollard survey 1146 vrs. S. 71° E. from its N. W. cor and at 1900 vrs. end of the 38th mile: Thence S. 30° E. 1436 vrs crossed Walnut Creek 1900 vrs end of the 39th mile: Thence S. 30° E. at 1383 vrs the south line of Comanche County and north line of Hamilton County as claimed by W. T. Soxon Surveyor of Hamilton County and 1700 vrs. to the above mentioned line as located by myself W. Livingston Ex Co. Surveyor of Mills Co. My Holman Ex County Surveyor of Comanche County and at 1900 vrs the end of the 40th mile: Thence S. 30° E. 1350 vrs North line of Jacob Becker survey 669 vrs. N. 71° W. from N. E. corner 1720 N. B. Cow-House Creek 1900 vrs end of the 41st mile Thence S. 30° E. 328 vrs. crossed E line Jacob Becker survey and west line S. M. Edwards survey at 1660 vrs. S. Branch Cow-House Creek 1900 vrs. end of 42^d mile Thence S. 30° E. 55 vrs. crossed the south line S. M. Edwards survey 1228 vrs S. 71° E. from S. W. corner and at 630 vrs. Brownwood and Hamilton Road 1900 vrs. end of 43^d mile on Brow of Mountain: Thence S. 30° E. 1020 vrs. crossed E. line S. M. Edwards sur. 1287 vrs. N. 19° E. from its S. E. corner 1900 vrs. end of the 44th mile on the W. S. Turbiville sur. on mountain: Thence S. 30° E. at 820 vrs. crossed the south line of said Turbiville survey 1115 vrs. S. 71° E. from its S. S. 71° W. from its N.E. corner at 1376 ws. crossed North line Wm Lancaster Survey 73 ws. N. 71° E. from its N.W. corner at 1900 ws. end of the 49th mile. Thence S. 30° E. at 525 ws. crossed the North line of L.P. Standifer survey 884 ws. Mill Creek at 1800 ws cross S. line of said Standifer Survey 516 ws. N. 71° E. from its South West corner 1900 ws. end of the 50th mile at foot of Mountain: Thence S. 30° E. at 969 ws. crossed the North line of the J.A. Nunley Sur. 538 ws. S. 71° W. from its N.E. corner at 1900 ws. end of the 51st mile. Thence S. 30° E. at 245 ws. crossed the South line of J.A. Nunley Survey 361 ws. S. 71° W. from its S.E. corner and at 1467 ws. crossed the S. line of the John McHakey Sur. 378 ws. S. 71° W. from its S.E. corner at 1900 ws end of the 52 mile on the Samuel Groves Survey; Thence S. 30° E. at 145 ws crossed the North line of the J.W. Collins Sur. 294 ws N. 71° E. from its N.W. cor. and at 1514 ws. crossed the S. line of said Collins Sur. 555 N. 71° E. from its S.W. corner and at 1900 ws. end of the 53rd mile on the A. Lemkkuhle Sur: Thence S. 30° E. at 1380 ws. crossed South Lampasas Creek at 1511 ws. crossed the South line of the said Lemkkuhle Sur. 917 ws. N. 71° E. from its S.W. corner and at 1900 ws. the end of the 54th mile: Thence S. 30° E. at 1517 ws crossed the South line of the L.V. + W. Ry. Co. Sur. #1. 1057 ws. N. 71° E. from its S.W. corner and at 1900 ws. end of the 55th mile on Mountain. Thence S. 30° E. 1051 ws. crossed the South line of the Andrew Greer survey 347 ws. N. 71° E. 347 ws. from its S.W. corner and at 1900 ws. end of the 56th mile. Thence S. 30° E. at 307 ws. crossed the N. line of the Taylor Smith Sur. 3532 ws. N. 71° E. from its N.W. cor. and at 1900 ws. end of the 57th mile. Thence S. 30° E. at 1900 ws. end of the 58th mile: Thence S. 30° E. 722 ws crossed the N. line of the George McKey Survey 308 ws. S. 71° W. from its N.E. corner

at 1900 ws. end of the 59th mile: Thence S. 30° E. at 742 ws.
crossed the South line of said McKey Survey and at 1900
ws. end of the 60th mile on the McVanks Survey: Thence
S. 30° E. at 622 ws. crossed the South line of said McVanks
Survey 196 ws S. 71° W. from its S.E. corner and at 1900 ws. End
of the 61st mile: Thence S. 31° E. at 810 ws. crossed the N. Line
of the J George Survey N. 71° E. 858 from its N.W. corner
and at 1529 ws. passed the S.W. corner of Hamilton County a
very large Stone set in ground by W. J. Soxon Surveyor of
Hamilton County in the year 1891 or 1892 for corner of Hamilton
and Lampasas Counties said Stone marked S.W. N.E. at 1900
ws. end of the 62^d mile: Thence S. 30° E. at 359 ws. the N.W.
corner of the J George Survey ws due East 30 ws at 515 ws.
crossed Bennetts Creek and at 579 ws. the S.E. corner of
Mills County on South Bank of Bennett Creek. a Pecan marked
L ws. N. 1° E. 40 ws. a Pecan marked M ws. N. 20° W. 50 ws.
Continuing from the above described S.E. corner of Mills County
and running South 56° W. at 12 ws crossed the East line
of the W. R. Adams Sur. its South corner S. 19° E. 31 ws. at 1900
ws. End of the 1st mile on this line: Thence S. 56° W. 1900 ws.
end of the 2nd mile on W. T. + B Ry. Sur #3. Thence S. 56° W. at
799 crossed the East line of N. R. Brister Sur. 690 ws. N. 19°
W. from its S.E. corner 1900 ws end of the 3^d mile: Thence S.
56° W. at 1465 ws crossed S. line of N. R. Brister Survey 668
ws. N. 71° E. from its S.W. corner 1900 ws. end of 4th mile
at foot of Mountain Thence S. 56° W. 1900 ws. end of the 5th
mile on Top of Mountain: Thence S. 56° W. 800 ws. leave Mountain
at 870 ws. crossed the West line of B. Payne Survey 55 ws N. 19°
W. from its S.W. corner 1900 ws end of the 6th mile. Thence S. 56°
W. at 944 ws crossed the East line of D. P. Coit Sur. 760 ws. N.
19° W. from its S.E. corner at 1700 ws. center of Sims Creek
1900 ws. end of the 7th mile: Thence S. 56° W. at 1345 ws crossed
the west line of D. P. Coit survey 165 ws 19° W. from its S.W.
corner 1900 ws the end of the 8th mile - Thence S. 56° W. at
1561 ws. crossed the E line of Sec. #5 E. T. R. R. Co. 33 ws. South

of its N.E. corner 1900 ws. the end of the 9th mile: Thence S. 56°
 W. at 840 ws. crossed the old Senterfitt and Center City Road
 1000 ws. enters Mountain 1900 ws. the end of the 10th mile
 on Mountain: Thence S. 56° W. at 53 ws. crossed the east line
 of Sec 6. E.T. R.R. Co. 619 ws. North of its S.E. corner at 1160 ws.
 crossed the South line of Sec 6. E.T. R.R. Co., 918 ws. from its
 S.E. corner at 1900 ws. the end of the 11th mile on top of
 Mountain: Thence S. 56° W. at 445 ws. East line of Sec. 10 E.T. R.R.
 Co., 663 ws. South of its N.E. cor. 1900 ws. the end of the 12th
 mile: Thence S. 56° W. at 758 ws. crossed South line of said
 Sec. 10. E.T. R.R. Co 65 ws. East of its S.W. corner. at 1900 ws. the
 end of the 13th mile on Mountain: Thence S. 56° W. at 1192
 ws. crossed the East line of Sec 13 E.T. R.R. Co., 554 ws N of
 its S.W. corner at 1200 ws. leave mountain at 1900 ws. the end
 of the 14th mile in the N. line of the John Norman survey
 738 ws west of its N.E. corner Thence S. 56° W. end of the 15th
 mile; Thence S. 56° W. at 225 ws. crossed the West boundary line
 of said Norman survey at 575 north of its S.W. corner at 1546
 ws. crossed the N. line of the E. Winston Survey 1670 ws. west
 of its N.E. corner at 1900 ws. the end of the 17th mile: Thence
 S. 56° W. at 1900 ws. the end of the 18th mile: Thence S. 56°
 W. at 803. ws. crossed N line of the Calvin Barker Swr. 1550 ws
 West of its N.E. corner at 1900 ws. the end of the 19th mile
 Thence S. 56° W. at 1900 ws. the end of the 20th mile on the
 Francis Nelson Thence S. 56° W. 1605 ws. to the waters edge
 in the Colorado River from this point N. 56° E. 60 ws erec-
 ted a large Stone mound above high Water mark at the
 root of a L.O. 18 inches in diameter marked M and 4 hacks
 from which another L.O. marked L and 4 Hacks ws. S. 26°
 W. 32 ws. at the end of each mile built mounds of Stone
 2 feet high the above survey was made by me on the
 ground beginning on 18th day of April 1898. and finishing
 on the 6th day of May 1898.
