REPORT AND FIELD NOTES OF A SURVEY OF THE BOUNDARY LINE

MITCHELL AND STERLING COUNTIES.

TO THE HONORABLE COUNTY COURTS OF MITCHELL AND STERLING COUNTIES:

Comes now, H. W. Stoneham, Special Surveyor duly appointed, qualified and acting Special Surveyor of Mitchell County, Texas, - for survey of boundary lines- under and by virtue of an order of the County Court of Mitchell County, Texas, at the July 1907 Term thereof by an order duly made and entered of record in the minutes of said Court in Book 3 Page Civil Minutes of said Court, and W. F. Kellis, Special Surveyor for Sterling County, Texas, duly appointed, qualified and acting as such under and by virtue of an order of the County Court of Sterling County, Texas made at the Regular August 1907 Term thereof, entered in the minutes of said Court in Book 1 on page Minutes of said court (a certified copy of which order is attached hereto and made a part hereof, together with certified copies of bonds of each of said surveyors) and beg leave to report as follows, to-wit:

That in accordance with an order of the County Court of Mitchell County, Texas, made and entered on the 15th day of July, 1907, appointing said H. W. Stoneham Special Surveyor for Mitchell County, Texas, and ordering a survey to be made of the boundary line of said Mitchell County, separating her from Sterling County, Texas, an order was made by the County Court of Sterling County, Texas, upon receipt of due and legal notice of such order, appointing W. F. Kellis to represent Sterling County in making said survey, and entered such order at the August Term 1907 of her County Court and forwarding a certified copy of said order to the County Court of Mitchell County, Texas in accordance with law. A certified copy of each and all of said orders above mentioned are attached here to.

That in accordance with said orders of said Courts said Special Surveyors each immediately began the collection of the necessary data at their respective places of residence and from the General Land Office of the State of Texas for the purpose of making said survey in the manner and form as requiredby law, and procured the necessary hands, wagons and implements with which to perform the survey in the manner and form as prescribed by Arts. 799 et seq of the Revised Statutes of the State of Texas 1895, and met in conformance with said order and by mutual agreement at the North-west corner of Coke County, Texas, which is hereinafter fully described on the 14th day of August, 1907 for the purpose of running and making the survey of the boundary line between Mitchell and Sterling Counties, Texas, in accordance with said order of date July 15th 1907 and the law governing such matters.

We beg leave here to refer to the Preliminary Report of H. W. Stoneham, Special Surveyor of Mitchell County, Texas, made at the October 1907 Term of the County Court of Mitchell County, Texas, for full information relative to the manner of the projection of random of trial line to the N. E. corner of Glasscock Countre and full particulars concerning all preliminary matters pertaining to said survey and a certified copy of said report and the order of the County Court of Mitchell County, Texas made and entered thereon are hereto attached and made a part hereof, together with copies of letters from the General Land Office of Texas in

DESCRIPTION AND FIELD NOTES OF BOUNDARY LINE.

October 1907. - Magnetic Variation 10 30' East.

Angle from Polaris in Western Elongation 1 24' .

BEGINNING at a stone monument marked on the East side "N. W. Cor Coke Co. March 11, 1891" and marked on the West side "N. E. Cor. T. G. Co. from which monument a Cedar Mountain bears-on the South side of the Colorado River bears South 59 East about 3 1/2 miles; the high point of a mountain South 24 30' East; the Northern Commer of Survey No. 20, Block No. 15, Southern Pacific Railway Company surveys bears North 9 05' West 1042 varas; the South corner of Survey No. 20 Block No. 15 aforesaid bears South 9 03' East 1644 varas; This point is now the North-east corner of Sterling County and the Ninth (9th) Mile Stone going from East to West along the Southern Line of Mitchell County, said point being here now adopted as such. South End of Hayrick Mountains bears North 58 West; Signal Mountain bears North 43 05' West; Big Springs Mountain bears North 50 03' West; A 6 pronged mesquite bears North 23 40' East 46.4 varas; A mesquite 6" in dia bears South 60 30' West 12.9 varas;


