M. on February 21st, 1929, and shall begin at the southwest corner of Ochiltree County, same being the southeast corner of Hansford County and run said line to the northwest corner of Ochiltree County, same being the northeast corner of Hansford County.

Said surveyor shall prepare a report, field notes and plat of such survey and make due return thereof to this Court in order that proper record may be made in the Minutes of this Court.

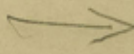
