

on this, the 22nd day of December A.D.1928, came on to be heard and considered by the court the matter of the petition of Jot Horton, acting for and at the request of the Commissioners Court of Hansford County, Texas, for the establishment according to law of the East Boundary line of said county, which is also the west boundary line of Ochiltree County, and it appearing to the satisfaction of this court that said boundary line is not sufficiently definite and well defined, and that a necessity exists for the establishment of such boundary line, and it further appearing to the court, after reading said petition and the facts introduced in evidence thereupon, that said petition should in all things be granted;

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the court that said petition shall be, and is hereby in all things granted, and a survey is hereby ordered to be made, and the East boundary line ofsaid Hansford County, which is also the West boundary line of said Ochiltree County, established, and made sufficiently definite and well defined as provided by law, and the initial corners of said survey shall be designated by posts, mounds or stone monuments in the manner and form and of the material provided for by law, as well as the posts at the end of each mile in said boundary line shall be placed thereat in like manner as provided by law, and the surveyors herein appointed shall make a plat and field notes thereof, and properly show thereon all of such corners and posts, as well as an accurate description of all prominent natural objects crossed by or adjacent to said line, as well as of the corners and lines of surveys on or near said boundaries, all of which shall conform to the law defining the boundaries of said county, and that when said line shall have been surveyed and marked as herein provided, that said surveyor shall make due return of said filed notes and map of this court, which shall be recorded by the clerk of this court, and a certified copy thereof returned

to the general Land Office, and said Surveyor, before entering upon the duties herein prescribed, shall take the cath of office prescribed by law for County Surveyors, and shall enter into bond in the sum of One Thousand Dollars, with two or more surcties to be approved by the County Judge of Hansford County, payable to the County Judge or his successors in office, conditioned for the faithful performance of his duty as provided by law.

It appearing to the court that T.O. James is an experienced and competent practical surveyor, and a State Licensed Land Surveyor, that said T.O. James is hereby appointed as the surveyor to run the lines and definitely fix and define the East voundary line of Hansford County, which is also the West boundary line of Ochiltree County, as herein provided, and said Surveyor shall begin the work thereof at 1:00 o'clock on the afternoon of February 21st, 1928, and shall begin at the Southeast corner of said County of Hansford, which is also the Southwest corner of Ochiltree County, and run said boundary line to the northeast corner of Hansford County, which is also the northwest corner of Ochiltree County, as herein provided, and a copy of this order, together with proper notice shall be sent to the County Court of Ochiltree County, Texas, being the other interested county in such boundary line, which notice shall s state the time and place when and where said survey will be commenced, as provided by law.

In compliance with your Order to establish and mark the east boudary line of Hansford County; We, the undersigned Licensed Land Surveyors met at the South-east Corner of

Hansford County at 1;00 o'clock P.M., on the 21st day of February A.D.1929, that being the place and time designated

in your order.

By agreement we adjourned to meet the 21st day of March at the North-eat corner of Hansford and North-west corner of Ochiltree Counties, being 30 miles west from the North-west corner of Lipscomb County, a large stone set by W.B. Twichell in year 1897; from which Clarks' Monument No.10 bears West 363.7 veras. (This Monument No.10 is now marked by concrete monument about 30" high set by U.S.G.L.O. Surveyors) At this time we proceeded to lay out and mark the said boundary line in accordance with our findings.
