of Oct 1906, ordering a survey and proper location of said line, and it
appearing to the Court that due and legal notice of said order was given the
County Court of Stephens County, and that at the time and place appointed
for the beginning of said survey, towit: the North West corner of Palo Pinto
County, and the North East corner of Stephens County, Dec 12, 1906
the Surveyor of said Stephens County appointed for the purpose of assisting
in the running of said line, failed to appear, and that M V Smith
Surveyor of Palo Pinto County at said time and place began said survey, and
completed same on the 27 day of Dec 1906 and that said survey was made
in all respects in conformity with law and with the order of the Court
directing and ordering said survey. And that said line was correctly surveyed
laid out, marked and established, with the proper marks, monuments and mile
stones and that said survey should be approved.

It is therefore ordered, adjudged and decreed by the
Court that said report of survey be and the same is hereby in all things
approved, and the line therein described shall hereafter be taken and held
to be the true boundary line separating said Palo Pinto and Stephens
Counties.
