

Field Notes of a Survey of the County
line between Jeff Davis and
Presidio Counties as made
by Dennis Corwin Surveyor
appointed by the County
Commissioners Court of
Presidio County and sur-
veyed August 29th. 1889 to Sept.
19th. 1889.

Beginning on the N.W. Corner
of Brewster County on the
S.E. corner of Sec. No. 36 G. O.
& S. F. Ry. Co. which is a stone
monument marked $\frac{N.E.}{S.E.}$ and near
the bottom of a deep gulch.
No. 1

Thence N. 60° W. and passing im-
mediately north of the North
twin mountain at 1700 varas sum-
mit of the high spur of said
mountain one mile and built
a stone monument in and near
the head of a gulch N.E. of the
highest point on the North
twin mountain, monument
marked $C\frac{1}{2}$

No. 2.
Thence north 60° W. passing along
the side of North twin mountain
one mile and built a stone
monument on the west side
of a deep ravine, marked $C\frac{1}{2}$.

Presidio Co. Bdry. Line 3

No. 3.

Thence North 60° W. rough and hilly one mile and set post in the valley of Mitre Creek 200 varas. S. 60° E. from the Creek marked $C\frac{1}{2}$

No. 4.

Thence N. 60° W. at 200 varas cross branch or Mitre Cañon Creek about one mile South of P. O. Murphy's house - crossing over high hill one mile and built stone monument on table lands marked $C\frac{1}{2}$.

No. 5.

Thence N. 60° W. small hills and plain one mile and set a post in valley on East side of road marked $C\frac{1}{2}$.

No. 6.

Thence 60° W. one mile, built a stone monument east of some live oak timber marked $C\frac{1}{2}$

No. 7.

Thence N. 60° W. one mile and built a stone monument by the west side of a draw or ravine marked $C\frac{1}{2}$

No. 8.

Thence N. 60° W. at 337 varas Murphy's fence 465 varas East of the S.W. corner of Section No. 763 G. O. & S. P. Ry. Co. one mile made stone monument marked $C\frac{1}{2}$.

No. 9.

Thence N. 60° W. one mile and built a stone monument on hill, marked $\frac{C_1}{9}$.

No. 10.

Thence N. 60° W. at 1160 vrs. the N.E. corner of Sec. No. 54 Bl. No. 1. Sect. No. 274 Texas and Pacific Ry. Co. as located by taking the said Block connection from Sur. No. 6 name of S. Lewis on which Fort Davis is situated. This corner is South 368 vrs. and west 649 vrs. from the S.W. corner of Sec. No. 36 Bl. No. 2. H. & P.C. Ry. Co. a rock mound on hill - continued. Thence west 740 vrs. set a post in the valley, marked $\frac{C_1}{10}$.

No. 11.

Thence west one mile crossing Ft. Davis and Marfa Road at 1455 vrs., set a post near the sharp point of a rocky hill, marked $\frac{C_1}{11}$.

No. 12.

Thence west one mile and built a stone monument on the West side of a hill near its brow, marked $\frac{C_1}{12}$.

No. 13.

Thence west, Lilly, one mile and built a stone monument in the valley 52 vrs. east of branch, marked $\frac{C_1}{13}$.

No. 14.

Thence West mostly all valley, one mile, built a stone monument marked $\frac{CL}{14}$.

No. 15.

Thence West one mile and set a post and built a mound on high ground, post marked $\frac{CL}{15}$.

No. 16.

Thence West one mile, valley land, set a post in valley on the east side of a branch, post marked $\frac{CL}{16}$.

No. 17.

Thence West level plain, one mile, set a post marked $\frac{CL}{17}$.

No. 18.

Thence West large valley, one mile, set post in flat prairie marked $\frac{CL}{18}$.

No. 19.

Thence West one mile, in large smooth valley, set a post N.E. of Charco Marine about a mile, post marked $\frac{CL}{19}$.

No. 20.

Thence West one mile, and set a post in the draw about $\frac{1}{2}$ mile above the house at Charco Marine marked $\frac{CL}{20}$.

No. 21.

Thence West one mile, set a post on the side of a hill, marked $\frac{CL}{21}$.

No. 22.

Thence west one mile, and built a stone monument on the west side of a hill between two hills with timber on, marked ^{CL} 22.

No. 23.

Thence west over sharp rocky points at 880 varas standing stones in line one mile made a stone monument west of hills by some large white rocks, marked ^{CL} 23.

No. 24.

Thence west at 494 varas the S.W. corner of a pasture fence bears north 112 varas, one mile, made a stone monument, marked ^{CL} 24.

No. 25.

Thence west, rough and hilly, one mile built a stone monument on east side of a hill marked ^{CL} 25.

No. 26.

Thence west, high hills, at 1227 varas across a branch with juniper timber on, one mile, built a stone monument on the east side of steep hill marked ^{CL} 26.

No. 27.

Thence west over high peak, at 1225 varas across a branch with trees on it, one mile, made monument on high hill Section-house at Ryan Station on the Rail road S. 51° W. monument marked ^{CL} 27.

No. 28.

Phence West, hilly, at 1500 varas entrance valley, one mile, and built a stone monument in valley marked $\frac{CL}{28}$.

No. 29.

Phence West at 490 varas old stone corner bears north 81 varas. This is the S.E. corner of No. 43 at 633 varas. old road at 1037 varas another road one mile and set a post in valley marked $\frac{CL}{29}$.

No. 30.

Phence West, level valley, one mile, and set a post marked $\frac{CL}{30}$.

No. 31.

Phence West one mile, level valley, set post west side of draw marked $\frac{CL}{31}$.

No. 32.

Phence West at 900 varas old road, one mile set a post in the flat, marked $\frac{CL}{32}$.

No. 33.

Phence West, all prairie, one mile, set post marked $\frac{CL}{33}$.

No. 34.

Phence West level prairie, one mile, set post in valley, marked $\frac{CL}{34}$.

No. 35.

Phence West 1667 varas center of Rail-road from which section marked no. 9189 + 50 bears N. 45° W. 290½ varas, set a post on line on N.E. side of said road marked CL continued in all one mile, set post marked $\frac{CL}{35}$.

No. 36.

Thence West, all prairie, one mile,
and set a post in the prairie,
marked ^{CL} 36.

No. 37.

Thence west at 500 varas the S.E.
Corner of section No. 19 Bl. No. 4
H. & P. Co. Ry. Co. marked by earth
mound and four pits bears
North 40 varas 1900 varas and
set a post marked ^{CL} 37.

No. 38.

Thence West valley land, one mile, set
post marked ^{CL} 38.

No. 39.

Thence West 506 varas past corner
of H. & P. Co. Ry. Co. Section no. 89. marked
by earth mound and four pits at
one mile, set post marked ^{CL} 39.

No. 40.

Thence west 500 varas to S.E. corner
of Sec. no. 90 Bl. No. 4. H. & P. Co. Ry.
Co. set a post marked Co. Cor. from
which the top of monument peak
bears N. 56° 20' E. (angle of elevation 4° 20')
and sharp peak bears N. 44° 15' W.

Thence North 1400 varas and set
post marked ^{CL} 40.

No. 41.

Thence North, one mile, level plain,
and set post in valley marked ^{CL} 41.

No. 42.

Thence north, level plain, one mile, set a post marked ^{CL} 42.

No. 43.

Thence north one mile, level plain, set post marked ^{CL} 43.

No. 44.

Thence north at 654 varas center of Railroad, Section marked No. 8872+70 bears N. W. on the road 416 varas, set a post on the S. W. side of Railway marked ^{CL} - one mile and set a post marked ^{CL} 44.

No. 45.

Thence north, all level country, one mile, set post marked ^{CL} 45.

No. 46.

Thence north at 1339 varas cross the Davis and Valentine road, one mile, set post in valley marked ^{CL} 46.

No. 47.

Thence north, level plain, one mile, set post marked ^{CL} 47.

No. 48.

Thence north one mile, set a post marked ^{CL} 48.

No. 49.

Thence north at 500 varas set a post for the N. W. corner of Sec. No. 81, Bl. No. 4, N. & P. C. Ry. Co. I found no marked corner at this point but one mile east and one mile west the corners are marked by earth mounds and four pits. Thence from this post N. 88° 50' W. 1400 varas and set post marked ^{CL} 49.

Thence N. $88^{\circ} 50' W.$, one mile, level plain set post marked $\frac{CL}{50}$.

No. 51.

Thence N. $88^{\circ} 50' W.$, one mile and set post marked $\frac{CL}{51}$.

No. 52.

Thence N. $88^{\circ} 50' W.$ at 5000 varas, section corner marked by earth mound and four pits bears South 116 varas one mile and set a post marked $\frac{CL}{52}$.

No. 53.

Thence N. $88^{\circ} 50' W.$, one mile on level plain set post marked $\frac{CL}{53}$.

No. 54.

Thence N. $88^{\circ} 50' W.$ at 1380 varas middle of Railroad section marked No. 85-03 + 10 bears S.E. 5-31 varas on the road, set a post on N.E. side of Railway marked $\frac{CL}{54}$ continued one mile in all set post marked $\frac{CL}{54}$.

No. 55.

Thence N. $88^{\circ} 50' W.$, one mile, set post in brushy ground marked $\frac{CL}{55}$.

No. 56.

Thence N. $88^{\circ} 50' W.$ at 900 varas hills begin - at 1900 varas, made a ~~stone~~ stone monument on south side of rocky hill marked $\frac{CL}{56}$.

No. 57.

Thence N. $88^{\circ} 50' W.$, one mile over low hills and set a post north of point of higher hills marked $\frac{CL}{57}$.

No. 58.

Thence N. 88° 50' W. sloping towards the west at one mile set a post in the valley marked $\frac{El}{58}$.

No. 59.

Thence N. 88° 50' W. one mile, all valley, set a post marked $\frac{El}{59}$.

No. 60.

Thence N. 88° 50' W. at 1744 varas branch with water holes Viejo Creek at one mile set post marked $\frac{El}{60}$.

No. 61.

Thence N. 88° 50' W. smooth prairie at one mile set post marked $\frac{El}{61}$.

No. 62.

Thence N. 88° 50' W. at 1000 varas a wagon road one mile and set a post marked $\frac{El}{62}$.

No. 63.

Thence N. 88° 50' W. one mile stone monument on the side of the mountain marked $\frac{El}{63}$. and from this point I ran random line to Rio Grande and began at the El Paso, Presidio, and Jeff Davis County corner and ran towards the East.

Beginning at a point on the Rio Grande river bank N. 19° 50' W. 1861 varas from the upper corner on the river, of Sur. No. 80 Bl. No. 2, Texas and Pacific

4 No. 1 Bl. No. 3. P. & P. Ry. Co. lands, for

6 This point is situated west
7 of a high steep mountain that

9 leaves no river valley. I found
10 no monument to indicate the
11 spot but ran up the river
12 from the upper corner of Sec.
13 No. 80, Bl. No. 2 which corner is
14 witnessed by a cave in the
15 perpendicular side of the moun-
16 tain and also by two peaks in
17 the Eagle Mountains and is a short
18 distance above the mouth of a
19 creek running into the river
20 on the Mexican side.

23 tain side No. 1.

25 Thence S. 88° 50' E. crossing a branch
26 one mile, stone monument in the
27 hills $\frac{1}{2}$.

29 Thence S. 88° 50' E. one mile and
30 built stone monument on
31 high point of pebbly hill marked $\frac{1}{3}$.

Thence S. 88° 50' rough foot hills, one mile, stone mound on side of mountain, No. 16. C.L.

Thence S. 88° 50' E. one mile, top of mountain stone mound No. 17. C.L.

Thence S. 88° 50' E. on mountain and East slope one mile and 880 varas to No. 63 C.L. in all 63,022 varas from El Paso County Corner to the N.E. corner of No. 126. N. & P. Co. Ry. Co. Block No. 4.
