16 good Stone or gas pipe, or throw up  
17 earth mound each mile run on said  
18 North boundary line of said County  
19 and do any and all other things necessary  
20 for establishing said boundary line between  
21 Randall and Potter Counties That said  
22 work begin at the North West Corner  
23 of Randall County and the North East  
24 Corner of Deaf Smith County and South  
25 East Corner of Oldham County, on, ~~and~~  
26 ~~at~~ the 14th day of May 1897,

27 And it is further ordered that the clerk  
28 of this Court send a copy of this order to  
29 the County Court of Potter County Texas

30 It is further ordered by the Court that  
31 said Surveyor be allowed Three Dollars  
32 per mile for each lineal mile run on

2 County, on the sum of \$90.00 for running  
3 and marking out definitely the 30 Statute  
4 miles as set fourth in field notes of  
5 said Randall County, to be paid upon  
6 the affidavit of said Surveyor on when  
7 work is done and approved by the


