Pursuant to the order of the Roberts County Court to survey, establish, and fix the west boundary of Roberts County, said order being dated April 15th. 1907, I, W.D.Twichell, a practical surveyor, duly appointed and fully qualified as required by law, was at the S.W. corner of Roberts County at 2:00 P.M. on May 21st., that being the place and time designated in said order. No other party or surveyor being present to participate in the survey, I thereupon proceeded to survey the boundary between Roberts and Hutchinson Counties as fbllows:-

Beginning at a concrete sone 24x8x8 marked ROB NW-Gray SE-H NE-C, and rock monument composed of three large stone, 2 feet high, on top of bluff, same being the N.W. corner of Gray Co., S.W. corner of Roberts Co. S.E. corner of Hutchinson Co., and the N.E. corner of Carson Co., whence an iron pipe marked 169 192 194 214 B3 B2 an the south bank of creek brs. east-780 and north-76 vrs. and the east point of a low flat hill brs. south-610 vrs.
