I desire to call your attention to another fact

If Mr Lewis (Kaufman Co's Surveyor) could move the S.W. Corner of Hunt County one and one half miles north, he or some other Surveyor could move that corner ten miles north. Now, suppose that some Surveyor should discover, that the true Corner of Hunt County was ten miles north of the point recognized by the legislature when Rockwall County was created, as the Corner of Hunt Co. and you should decide that the south line of Rockwall County should follow, the removal of the S.W. Corner of Hunt Co. What would be the result? The result would simply be the utter annihilation of Rockwall County. I suggest, that if you can remain the S.W. Corner of Hunt Co, one and one half miles north, you can remove it ten miles, and wipe Rockwall County. Draw the map of the State of Texas.
