

Field Notes of the South Boundary  
line of Rockwall County

To the Honorable County Court of  
Rockwall County

In obedience to your order made on the  
17<sup>th</sup> day of November at a regular  
term of the County Court and C B  
Ashurst was appointed as special surveyor  
or to act in conjunction with such  
surveyor as shall be appointed by  
Kaufman County to ascertain establish  
and mark the South boundary line of  
Rockwall County which forms a  
part of the north boundary of Kauf-  
man County - on the 28<sup>th</sup> day Nov 1892  
the day set I proceeded to the post set  
up by Kinney & Kyser for the S W  
corner of Hunt County It being about  
the place recognized as the corner estab-  
lished by Wright in 1846 and being the  
point recognized as such when Rockwall  
County was laid off by Brewer &  
Barnes I ran south from said point  
intersecting a line I formerly ran  
being West of the corner from which  
said line was run being two miles  
south of the corner as set up by Sherw-  
ood & Money Dec 13 & 14 - 1880 at which  
place I put up a post for corner Marked  
RC ~~TC~~ on NW side & on the SE side KC  
and is East of the SW line of the  
Elizabeth Graves League & Caver 150 are it  
being two miles east of the two mile post  
put up by Brewer & Barnes thence  
west with Brewer & Barnes line as per  
former report and for a more full report

I refer to my rout plat made of survey  
I made of said line on the 26<sup>th</sup> Jan  
1892 the line crosses the S W line of  
Elizabeth Graves League 10 1/4 or 1/2 North  
45° W of the South corner of said league  
extending west to Dallas line as per  
former survey which is made a part of  
this report all of which is respectfully
