In the recent resurvey of the S. line of Runnels County from its S. W. corner to the N. W. corner of Concho County, which is also a portion of the North line of Tom Green County, we find that the following surveys, formerly abstracted as being part in Runnels and part in Tom Green Counties, are wholly within Tom Green County, to-wit:
