To the Commissioner of the General Land Office,
Austin, Texas.

Dear Sir,

According to promise ^{made} to you recently when in your Office endeavoring to have the printed Abstracts issued for the corrected Abs of the lands through which the South line of San Saba ^{county} runs. I send the following data made on the ground while running said County line. "to wit"

The mouth of Fall Creek (the initial cor. of San Saba County) is 416 varas North & 217 varas East from the S.E. cor. of survey N^o 464 in name of P.H. Schupp.

Running West at 6 miles 1640 varas crossed the west line of N^o 170 in the name of P. Bodeman 242 varas North of its S.W. cor.

The 12 mile stone is 20 varas West of the S.W. cor. of J.H. Calison.

The 14 mile stone is 180 varas West of the S.E. cor. of N^o 561 - M. Bartholomae.

The 20 200 varas South & 200 varas West of the S.W. cor. of N^o 547. E.E. Case

The 22 936 .. South of N.W. cor. of school 1/2 Sec - J.F. Jory scrip.

The 26 290 .. South of S.E. cor. of N^o 207 - C. Grape v.

The N.W. cor. of N^o 86 - C. Fitz is 1140 varas North of Co line.

At 31 miles 612 varas I crossed the West line of N^o 16 in name of Messel Meyer. 600 varas South of its N.W. cor. - 400 varas South of South line of N^o 63 - A. Bremme (those survey conflict 200 var. N. & S. and same E & W at S.E. cor. N^o 63) The County line runs

475 varas South of the N.E. cor. of N^o in name of W. Lange. See its N.W. cor. the N.E. & N.W. cor. C.F. Striplin N^o 60. Andrew Paterson

& M.K. Sheppard. The North line of N^o 38 is slightly diagonal causing the N.W. cor. to be 100 varas North of the N.E. cor. The ^{North} line is 2230 varas long.

The S.W. cor. of San Saba is 950 varas West and 537 varas South from the N.E. cor. of the McAshan Section. Respectfully submitted and to all of which I certify.
