 County of Tarrant } To the Hon County Court
 of the County above mention-
 ed, The undersigned A G Walker Surveyor appoi-
 -nted by your Hon Body at the Term of your
 Court " to Run the South and West Boundaries
 of Tarrant County and the unfinished part
 of the North and that he put in a good and
 durable Rock or Post at the End of each Mile,
 Number of Miles to the Corner, from which he is
 running &c. &c. Beg leave to Report that in pursu-
 -ance to said Order he proceeded on Monday
 the 23rd day of October AD 1854, at the time and
 place designated, by the Hon Chief Justice of the
 County and State aforesaid, to wit, between
 the hours of 8 & 10 o'clock of that day and at
 the South West Corner of Dallas County, as
 made and established by Warren a Harris, a
 Copy of the Field Notes of which was procured
 by the undersigned from Mr J. H. Harris
 the County Clerk for said County and which
 is herewith presented and Prayed to be filed
 with this Report as a part of it.

The undersigned would further state that at the End
 of each Mile in the prairie he placed in the
 ground a Post with the number of Miles on it,
 from the Corner of the County from - he was
 running, on one side, and the letters T.C.L. on the
 other side and in timber sd. Posts and letters were
 cut on the nearest durable looking trees, to the
 End of each Mile and that he dug a good and
 durable well in each of the said Miles
 and also the
 head with sd Boundaries all of which is more
 described in the following Field Notes to w.

Beginning at the South West Corner of Dallas
 County a small Cedar Stake in a mound, on
 the South East Bank of a small Ravine.
 from which a Musket. 10 in. bore N 27° E 62 1/2 W
 Thence West at 1010 W. Timber - at 1520 W. Mountain
 Creek 15 W. wide and course North East, at 1750 W.

- 21 Here I quit and went to the 21 Mile mound as made and established by George White Surveyor appointed by the Denton County Court for the purpose of Running the South Boundary line of S. County Then ran west at 600 vs crossed Hemmetta Creek 5 vs wide came N.E. at 796 vs passed the South West Corner of Denton County found as described in the Field Notes of the S. Surveyor. of the said South boundary at 1430 vs recrossed S. Creek Co. S.E. in all
22. 1900.8 vs. To the 22 Mile Post in a Mound about 500 vs South of a drain Co. M. A.
- 23 West 1900.8. vs to the 23 Mile Post in a mound on high Prairie
- 24 West. 1900.8 to the 24 Mile Post in a mound on the East side of a hill on the East side of Indian Creek
25. West 1900.8 vs to the 25 Mile Post in a mound about 150. vs. East of the North End of Limber on a branch of S. Creek
