2 Throckmorton County June 20<sup>th</sup> 1892,  
3 And now at this time came on to be  
4 considered, the matter of the North boundary  
5 line of Throckmorton County and it appear-  
6 ing to the satisfaction of the Commissioners  
7 Court of said County of Throckmorton that  
8 the North line of said County is not suffi-  
9 ciently definite, and well defined. It is order-  
10 ed by the Court that C. K. Stibbling County Sur-  
11 veyor of Throckmorton County an experien-  
12 ced, Competent and practical Surveyor be  
13 and is hereby appointed to ascertain by  
14 actual survey the North line of said  
15 County and to make and establish the line  
16 and corners in the manner prescribed by law  
17 to wit: The North Boundary line of said  
18 Throckmorton County, The North East and Nor-  
19 th West Corners of said Throckmorton County  
20 And after taking the Oath of Office prescribed  
21 by Law and entering into bond in the sum  
22 of One Thousand Dollars (\$1000<sup>00</sup>) with two or  
23 more Sureties to be approved by this Court,  
24 Conditioned for the faithful performance  
25 of his duty, the said C. K. Stibbling shall be-  
26 gin at the North West Corner of Young Cow-  
27 nty on Thursday the 25<sup>th</sup> day of August A. D.  
28 1892. and shall run the lines and establish the  
29 corners as aforesaid in the manner prescribed  
30 by law, and shall report his action together with  
31 the Field notes and descriptions of said lines  
32 and corners aforesaid to this Court as the

1 law requires, and it is further ordered that  
2 the Clerk of this Court, sends by registered mail  
3 a Certified Copy of this order to the Clerk  
4 of the Commissioners Court of Baylor County  
5 at least ten days before the 2<sup>nd</sup> Monday in  
6 August 1892, same being the 8<sup>th</sup> day of said  
7 month.

8 C. K. Stribling County Surveyor Pres-  
9 ented his bond for \$1000<sup>00</sup> as Special  
10 Sur, with W. Y. Andrews & M. L. McCabe as  
11 Sureties for the faithful performance of  
12 his duties as aforesaid, which was exam-  
13 ined and approved by the Court.
