To the Honorable  
Commissioners Court of Tom Green County,  
Gentlemen:

By virtue of an order of  
your Honorable Court, made on the 12<sup>th</sup> day  
of February A.D. 1891, appointing me  
Surveyor to assist in surveying, and es-  
tablishing the line between Concho and  
Tom Green Counties on May 21<sup>st</sup> 1891, and  
an amendatory order of your Court made  
April 13<sup>th</sup> 1891, changing the date of said  
survey to June 15<sup>th</sup> 1891, and after having  
given bond and qualified as the law  
directs, I proceeded to the S.E. Corner of  
Tom Green County and there met H.M. Gardner  
County Surveyor of Concho Co. on the 15<sup>th</sup> day  
of June 1891, and we jointly surveyed as  
follows, to wit:—

We began at a large stone  
monument capped with a stone which is  
marked CORNER of M'D. C'HO, SCH. &  
TG. Counties. June 8<sup>th</sup> 1891, from which a  
Live Oak 10' marked  $\equiv$  brs. S 30<sup>th</sup> W. 37<sup>1</sup>/<sub>5</sub> varas  
a double Live Oak each prong 12' in dia.  
marked  $\equiv$  M'D brs. S 59<sup>th</sup> E. 148<sup>4</sup>/<sub>5</sub> varas, a Live  
Oak 6' in. dia. marked  $\equiv$  C bears N. 27<sup>1</sup>/<sub>4</sub> E. 77<sup>1</sup>/<sub>4</sub>  
varas, a Live Oak 12' in. dia. marked  $\times$  bears  
S 81<sup>1</sup>/<sub>2</sub> W. 20<sup>1</sup>/<sub>2</sub> varas, a Live Oak 12' in dia.  
marked  $\equiv$  TG bears N. 34<sup>1</sup>/<sub>2</sub> W. 121<sup>1</sup>/<sub>5</sub> varas said  
stone mound is exactly 10 miles North

and 30 miles West from the S.W. Corner of  
 McCulloch County, which is a stone and with  
 large stone marked 65 MILES. S.W. Cor. M & C.  
 Co. from which a double Live Oak marked  
 $\frac{X}{X}$  bears N. 38 E 53 varas and a Live Oak 8 in.  
 dia. bears S. 65  $\frac{1}{4}$  E 44 varas, it is also 6  
 miles and 95 varas west and 111 varas  
 south from the N.E. Corner of Survey No.  
 121 in name of E.L. & R.R. R.R. Co. which was  
 found and identified, it is also 219 varas  
 North and 4153 varas East from the N.E.  
 Corner of Survey No. 5 Bk. "H" G.H. & S.A.R.R. Co.  
 also found and identified, and it is 1030 varas  
 East and 1166 varas South from the S.W.  
 Corner of Survey No. 17 Block No. 8 H. & T.C.  
 R.R. Co. which was found and identified.

1. Thence North at 1166 varas cross the S.  
 line of survey No. 17 Block 8. H. & T.C. R.R. Co  
 1030 varas East from its S.W. corner. at 1325  
 varas cross South fence of "Kickapoo Pasture"  
 at 1900 var. build a stone monument marked  
 1 MILE T.G. & C. Co. LINE.

2 Thence North at 1155 varas cross the  
 North line of Sur. No. 17 & S. line of No. 18 Bk.  
 No. 8. - 862  $\frac{1}{2}$  varas West from the S.E. corner of

19 East 840 varas, a stake & stone md. fr. which  
20 a Live Oak 18' in dia. bears N.  $8\frac{1}{2}$ ° W.  $19\frac{1}{2}$  varas  
21 marked  $\times$ , at 1368 varas cross the South  
22 line of Survey No. 3 T. & N. 3rd N. G. R. R. Co.  
23 1300 var. East from its S.W. corner. 1900 varas  
24 set stone monument marked 5 MILES T.G. &  
25 C. Co. LINE.

27 S.E. line of Survey No. 431 Leonard Breit

32 Hearn preemption  $475$  varas N.  $45$ ° W. from the

1 East corner of said No. 431, at 1435 varas  
 2 Kickapoo Creek at 1460 varas a rock bluff. 1900  
 3 varas set stone monument in thicket marked  
 4 6 MILES T.G. & C. Co. LINE from which a Burr  
 5 Oak 6' in dia. bears N. 35 W.  $1\frac{3}{5}$  varas

7. Thence North at 13 varas the East  
 7 corner of James Green Survey No. 2 bears West  
 8 638 varas which was found & identified &  
 9 which calls to be on the South line of Geo.  
 10 Self Survey No. 21, 154 varas East from S.W.  
 11 corner of said No. 21, at 994 varas the S.E.  
 12 corner of Survey No. 19 Indianola R.R. Co.  
 13 bears West 800 varas. which was found and  
 14 identified, by stone mound from which a




