 counties of Polk & Trinity } division line between  
 } Polk and Trinity  
 } counties. Beginning at a line Mulberry  
 tree which is situated on the east-mar-  
 gin of Trinity River, at a point of about  
 N. 56 W. 10000 varas distant from  
 the mouth of Kickapoo Creek, and  
 S. 39. E. 730. vrs from where the divi-  
 sion line between the two A. M. de  
 Legarza Leagues Touches the east bank  
 of Trinity River. Said Mulberry is  
 marked on its eastern side P<sub>x</sub> and  
 on its western side T<sub>1</sub> from which  
 an ash 14<sup>m</sup> dia. Mk'd P<sub>x</sub> br. S. 64. E.  
 12 vrs a cotton wood 30 in dia Mk'd  
 P<sub>x</sub> br N. 50. E. 27-1/4 vrs an ash 18<sup>m</sup> dia.  
 Mk'd T<sub>x</sub> br N 31. E. 21-1/4. vrs and a  
 Sycamore 8<sup>m</sup> dia Mk'd "Polk." br  
 S. H. W. 4 1/2 vrs. Thence N. 49. E. at 200.  
 vrs. a bluff or bank of apparently  
 an old river at 1300. vrs to the edge  
 of river swamp at 1900 varas. an  
 earth mound in an old field for 1<sup>st</sup>  
 mile. Thence (Thence" here refers to  
 course N. 49. E. to mouth of Bull Creek  
 from there on to mouth of Alabama  
 Creek to course N. 40. 30. E.) at 1900.  
 varas an earth mound for 2<sup>nd</sup> mile. Whe-  
 nce two pines each marked two hacks  
 and one of same marked P. Thence

at 1300. Brushy Creek. Course south  
at 1900. vs. earth mound for 3<sup>rd</sup> mile  
Whence a forked Sweet gum and a *Gym.*  
each marked three hacks Thence at  
1900. vs an earth mound for  
4<sup>th</sup> mile Whence two pines each  
has five hacks, Thence at 1900. earth  
mound for 5<sup>th</sup> mile Whence two pi-  
nes each marked five hacks Thence  
at 1900 vs. earth mound for 6<sup>th</sup>  
mile Whence two pines each marked  
six hacks. Thence at 1900 vs. earth  
mound for 7<sup>th</sup> mile Whence two pines  
each marked seven hacks. Thence  
at 1900 vs. earth mound for  
8<sup>th</sup> eighth mile Whence two pines  
each marked. eight-hacks, Thence  
at 1800 vs to Middle of Kickapoo  
Creek at 1900 vs earth mound for  
9<sup>th</sup> mile. Whence an ash tree and  
a white oak each marked nine hacks  
Thence at 1900. vs earth mound  
for 10<sup>th</sup> mile. Whence three pines each  
marked. ten hacks - Thence at 1900  
vs earth mound for 11<sup>th</sup> mile Whence  
three pines each marked eleven hacks.  
Thence 1900. vs. earth mound for  
12<sup>th</sup> mile Whence three pines each marked  
twelve hacks, Thence at 1900. vs. earth  
mound for 13<sup>th</sup> mile. Whence two pines  
each marked thirteen hacks, Thence

at 1900. vs. earth mound for 14<sup>th</sup>  
mile Whence two pines each marked  
fourteen hacks. Thence at 500. vs road  
from Groveton to Salita at 1900 vs  
earth mound for 15<sup>th</sup> fifteenth mile  
Whence three pines each marked fif-  
teen hacks. Thence at 1900 vs. earth  
mound for 16<sup>th</sup> mile Whence two pines  
and a black jack. each marked sixteen  
hacks. Thence at 1900. vs. rock mound  
for 17<sup>th</sup> mile. Whence a black gum and  
a pine each marked seventeen hacks  
Thence at 1150. vs Cross P. & S. R. R.  
320. vs. east of its 28<sup>th</sup> mile post at  
1690. vs. Cross the road from Groveton  
to Moscow at 1900 vs. earth mound  
for 18<sup>th</sup> mile. Whence a pine and red  
oak each marked eighteen hacks.  
Thence at 1900 vs. earth mound on  
west bank of Bull Creek for 19<sup>th</sup> mile.  
a magnolia and a sweet gum. each  
marked nineteen hacks. Thence at  
100 vs Cross Bull Creek at 1900 vs.  
earth mound for 20<sup>th</sup> mile. Whence  
a black gum and hickory. each  
marked twenty hacks. Thence. Cross-  
ing said Bull Creek several times  
at 2045. vs the mouth of Bull Creek  
at big Piney Creek, at which point  
a hewn Mulberry post 8 in. dia. was  
set, marked on eastern side P. on

Western side  $T_x$ . Whence a Sweet Gum  
 stands on east bank marked  $F_x$  a  
 birch stands on west bank marked  $T_x$   
 Beginning at said post (a different  
 course was run) Thence N.  $40^{\circ}$  -  $\frac{1}{2}$  E. at  
 1900 vs earth mound for 1<sup>st</sup> mile.  
 Thence at 800. vs. Nugent Creek  
 at 1900 vs. earth mound for 2<sup>nd</sup>  
 mile. Whence a pine and hickory  
 each marked three hacks, Thence  
 at 1900 vs. earth mound for 3<sup>rd</sup>  
 mile. Whence two pines, each marked  
 four hacks, Thence at 200 vs. ~~to~~  
 Moscow and Centralia road at 1900.  
 earth mound for 4<sup>th</sup> mile. Whence  
 two pines each marked five hacks -  
 Thence 1900 vs earth mound for  
 5<sup>th</sup> mile. Whence a Sweet Gum and  
 a Post Oak each marked six hacks,  
 Thence at 1900. earth mound for  
 6<sup>th</sup> mile. Whence a pine and a Post  
 Oak each marked seven hacks,  
 Thence at 1900. vs. earth mound  
 for 7<sup>th</sup> mile. Whence a Post Oak  
 marked twenty eight hacks. Thence  
 at 1900. vs rock mound for 8<sup>th</sup> mile  
 Whence a tree marked twenty nine  
 hacks. Thence at 1990 vs to the mouth  
 of Alabama Creek at Neches river.  
 At this point on the east bank of said  
 Creek a lightwood Post 4 ft long. 8. <sup>in</sup>

dia. is set in the ground about three ft. deep. Marked  $T_4$   $P_4$ . Thus completing the line. The total distance or length of said line being 30 miles & 35 rods. Survey was finished August 7<sup>th</sup> 1884. Four hacks on the trees marks this county line.
