Dear Mr. Jones:

This is with reference to your letter of September 19 relative to the field notes of the Webb-Dimmit County line.

The matter of adjustment and determination of county lines in this state is one which must be settled by the counties affected, unless such counties are unable to agree and they refer the matter to the Land Commissioner to be determined.

You state in your letter, "We are willing to accept the survey with certain reservations applying to that part of the line within the boundaries of the aerial gunnery range." Therefore, until such time as the retracement of this line has been fully approved by both counties, there is nothing further this department can do in the matter.

When full agreement has been reached by both counties, then a certified copy of the Court Orders of the County Courts from both Dimmit and Webb Counties, accepting and approving the field notes, must be furnished this office; also a certified copy of the Court Order from both counties directing the surveyor to survey this line.

An examination of the field notes of this survey reveals that they are certified to and signed by Mr. E. J. Foster. The signature and certificate of both surveyors are required. The certificate by Mr. J. A. Rodriguez, Clerk of the County Court, has not been signed.

As the abstract of practically all the surveys along the line will have to be corrected, it is absolutely necessary that both counties are in accord and complete agreement before this office can file the field notes and, especially, correct the abstracts.
