



1 Report of a survey of the County line between
2 Willbarger and Foard and between Willbarger
3 and Hardeman Counties, made by order of the
4 Commissioners Court of Willbarger County at its
5 special term July 7th 1893.

6 Begin at the established N.W. corner of Baylor
7 County a large sand stone rock 3 feet x 3 feet
8 facing North and South and situated in the
9 valley of South Beaver Creek marked $N \frac{E}{X} | N. \frac{W}{T}$
10 on the south side and H! W on the north side
11 a large hackberry tree br. N. $25\frac{3}{4}^{\circ}$ E 128 vs.
12 and another br. N. $21\frac{1}{2}^{\circ}$ E 131 vs and a round
13 lone mound br. S. $57\frac{3}{4}^{\circ}$ W. 212 vs. All of the
14 above bearings are found at the course and
15 distance called for in the field notes but the
16 trees are not marked.

18 Beaver Creek at 1281 vs. the South line of Sec.
19 64 Blk. 18 T. & J. C. R. Co. 583 vs. from its S. E.

- 9-24 Thence North at 68 vs. cross the S. line of sec.

- 16 20 Thence North at 80 vs. cross the north line
21 of sec. 11 Blk. 8, 659 vs. from its N.W.
22 corner at 1900 $\frac{8}{10}$ vs. a red sand stone 3
23 feet high marked 17 $\frac{1}{2}$ on the E side and
24 F on the west side. This stone is on the
25 East side of a sandy high bluff on the
26 South side of Pease River, from which
27 a Chittum brs. S $49\frac{1}{4}^{\circ}$ E. 25 vs. and 2
28 Chittum 5" chain. brs. N. $54\frac{1}{2}$ $\frac{1}{2}$ $\frac{1}{2}$ vs.


