County of Nueces;

Field notes of a tract of land situated in the State of Texas, containing about 1920 square miles, being about 342 square miles of Hidalgo County, and about 1578 square miles of Cameron County, said tract being known as Willacy County, created by an act of the Thirty second Legislature of the State of Texas at its regular session of January, 1911, as surveyed by A.M. French, the surveyor elected by the Commissioners of said Willacy County to run and establish the boundaries of said Willacy County, in conformity with the said act;

Beginning at a Cement monument, marked N on the North side and W on the S. E. side and B on the S. W. side, which is on the South line of Nueces County, set for the N. E. corner of said Brooks County, and N. W. corner of Willacy County, said Willacy County, being also created by act of the Thirty second Legislature of the State of Texas at its regular session of January, 1911; (the point at which this corner was set was determined by the said A. M. French and C. F. H. Von Blucher, the surveyor elected by the Commissioners of said Brooks County to run and establish the boundaries of said Brooks County, by running the West line of the Santa Rosa de Arriba Grant North to intersect the South line of Nueces County, as the said West line was established by decree of the District Court of Travis County, in cause No. 18899 styled "The State of Texas versus D. R. Fant")

Thence with the West line of said Brooks County $S.0^{\circ}$ 9' 19" E. at 482 varas cross Mrs. H. M. Kings South fence, at 625 vs center of small pond at at 1352 to 1382 vs Paisano Creek, runs S. of E. at 1900.8 vs set a cedar post, marked 1 on the North side, W on the East and B on the West side; for the 1st mile;

Thence on same course at 957 to 1029 vs, Palo Blanco Creek, runs S. E. at 1900.8 vs set a Cedar post marked 2 on the North side W on the East side and B on the West side;

Thence on same course, at 1900.8 vs set a Cedar post marked 3 on the North side, W on the East side and B on the West side for the 3rd Mile;

Thence on same course, S.O^O O9' 19" E. at 898.5 vs pass the S. E. corner of El Tule Grant, at 978.6 vs the N.W. corner of said Santa Rosa de Arriba Grant as established as aforesaid, in the Olmos Creek, at 1009 vs the South bank of said Creek, at 1900.8 vs set a Cedar post marked 4 on the North side, W. on the East side and B on the West side:

Thence on same course, at 14 22.5 vs pass 1.65 vs West of an old stake marked H on the West side, at 1900.8 vs set a Cedar post marked 5 on the North side W on the East side and B on the West side;

Thence on same course, at 524 vs just East of a large lake, at 792 vs enter Zacahuistle flat, at 1779 vs enter lake at 1886 vs leave same, at 1900.8 vs set a Cedar post marked 6 on the North side W on the East side and B on the West side;

Thence on same course S.0° 09' 19" E. at at 119 to 298 vs in lake at 1900.8 vs set a Cedar post marked 7 on the North side W on the East side and B on the West side:

Thence on same course, at 1310 vs enter Live Oak timber at 1900.8 vs set a post marked 8 on the North side W on the East side and B on the West side;

Thence on same course, at 935 vs cross road, at 1900.8 vs set a

Cedar post marked 9 on the North, W on the East and B on the West;

Thence on same course, at 864 vs a lake with water to right of line, at 1900.8 vs set a Cedar post marked 10 on the North side W on the East side and B on the West side;

Thence on same course S.0⁰ 09' 19" E. at 767 vs enter sand dune, at 1681.8 vs pass the S. W. corner of Santa Rosa de Arriba Grant, as established by decree of the District Court of Travis County, in the cause of the State of Texas versus D. R. Fant as before set out, at 1474 vs leave sand dune, at 1900.8 vs set a Cedar post marked 11 on the North side, W. on the East side and B on the West side;

Thence on same course, at 1476 to 1800 vs in Zacahuistle flat, at 1900.8 varas set a Cedar post marked 12 on the North, W on the East and B on the West side;

Thence on same course, at 1900.8 vs set a Cedar post marked 13 on the North, W on the East and B on the West side;

Thence on, same course, at 515 to 680 vs in a Zacahuistle flat, at 1900.8 varas set a Cedar post marked 14 on the North side W on the East side and B on the West side;

Thence on same course S. 9° 09' 19" E. at 1415 vs enter sand dune, at 1900.8 vs set a Cedar post marked W on the East side B on the West side and 15 on the North side,

Thence on same course, at 34 vs leave sand dune at 1900.8 vs set a Cedar post marked 16 on the North, W on the East and B on the West; Thence on same course at 1900.8 vs set a Cedar post marked 17 on the North side W on the East side and B on the West side; in Zacahuistle flat;

Thence on same course, at 1137.8 vs a fence said to be on Section line runs Westerly, at 1900.8 vs set a Cedar post marked 18 on the North W on the East side and B on the West;

Thence on same course, at 1900.8 vs set a Cedar post marked 19 on the North W on the East and B on the West side;

Thence on same course at 1175.6 vs cross a fence 54 feet West of corner, at 1900.8 vs set a Cedar post marked 20 on the North side W on the East and B on the West side;

Thence on, same course at 1900.8 vs set a Cedar post marked 21 on the North side W on the East side and B on the West side;

Thence on same course at 450 vs leave Live Oak, at 1207.8 vs the S.W. corner of Survey No. 75 and N. E. corner of Survey No. 85 Tex. Mex. Ry. bears N. 89° 50' 41 E. 1000.4 vs at 1900.8 vs set a Cedar post marked 22 on the North side W on the East side and B on the West side;

Thence on, same course (S.0° 09' 19" E.) at 801 to 907 vs cross East end of lake, at 1052.8 vs the N. E. corner of Santa Quiteria Grant bears N. 89° 50' 41" E. 3405.2 vs, at 1267 to 1353 vs cross a lake, at 1900.8 vs set a Cedar post marked 23 on the North W on the East and B on the West sides;

Thence on same course, at 236.9 vs cross a fence, at 450 to 605 vs a lake, at 1900.8 vs set a concrete post marked 24 on the North side, W on the East side and B on the West side;

Thence on same course, at 100 to 198 vs a lake, at 491 to 637 vs a lake full of water, at 1900.8 vs set a Cedar post marked 25 on the

North side W on the East and B on the West;

Thence on, same course, at 1900.8 vs set a Cedar post marked 26 on the North side W on the East and B on the West; in a Zacahuistle flat;

Thence on, same course at, 1584 to 1836 vs in flats or dry lakes, at 1900.8 vs set a concrete post marked 27 on the North side W on the East side and B on the West side:

Thence on, same course (S. 0° 09' 19" E.) at 360 vs enter sand dunes, at 540 vs leave same, at 1900.8 vs set a Cedar post marked 28 on the North side W on the East and B on the West;

Thence on, same course at 1900.8 vs set a Cedar post marked 29 on the North side, W on the East side and B on the West side;

Thence on same course (S. 0°.09' 19" E.) at 288 vs a small pond about 28 vs to the West, 1900.8 vs set a concrete post marked 30 on the North side, W on the East and B on the West side;

Thence on same course at 162.9 vs cross a fence supposed North line of San Salvador del Tule grant, crossing our line on a course of S. 82° 10' E. and measure up fence N. 82° 10' W. 1127 vs to a stake set by the County surveyor of Hidalgo County for the S. E. corner of of the Mary McFarland Survey No. 734, at 1188 vs enter Zacahuistle flat, at 1900.8 vs set a Cedar post marked 31 on the North side, W on the East side and B. on the West side;

Thence on same course, at 210 vs out of Zacahuistle flat, at 864 vs in-scattering Mesquite, at 1900.8 vs set a Cedar post marked 32 on the North side W on the East side and B on the West side;

Thence on S. 0° 09' 19" E. at at 1900.8 vs set a concrete post in prairie, marked W on the N. E. and S. E. sides, H on the S. W. side, and B-33 on the N. W. side, for the 33rd Mile also the S. E. corner of Brooks County, and a corner of Hidalgo County, whence the Coyote Windmill bears S. 82° 10' 19" E., Chrissostomo mill bears S. 75° 10' 41" W. and the Gigante N. 49° 43' W.

The foregoing line was run by C. F. H. Von Blucher and A. M. French jointly, all the Cedar posts are 6 inches in diameter at the small end, and 5 feet long, and set 3 feet in the ground, the Concrete posts are re-inforced, and are about 5 inches square at the top and 8 at the base, and are set in the ground from 3-1/2 to 4 feet; being 6 feet long.

Here Mr. Blucher left me, he running Westerly.

Thence from the S. E. corner of Brooks County, on same course (S. 0° 09' 19" E.) over prairie at 1900.8 vs set a Mesquite post marked 34 on the North, W/on the East and H on the West;

Thence on same course, at 1350 vs Mrs H. M. Kings Andrea ranch mill bears S. 17° 16' W., house S. 7° 38' W., at 1900.8 vs set a Mesquite post marked 35 on the North W on the **East**and H on the West:

Thence on, same course, at 750 vs Andrea house bears S. 13° 41' W. 3 at 1900.8 varas set a Mesquite post marked 36 on the North W on the East and H on the West sides;

Thence on same course at 5 vs Andrea House bears S. 36° 21' W., mill S. 40° 26' W. at 27 vs cross road to Katherine, runs N.NE.at 011.4 vs cross small pasture fence on line of pens about N. 86° W. at 1181 vs cross fence of small pasture, about S. 18° E. at 1900.8 vs set a Mesquite post marked 37 on the North side W on the East and H on the West;

Thence on same course at 1504 vs cross fence between the pastures of Mrs. H. M. King and Estefano Lopez de Garza, runs about S. $72-1/2^{\circ}$ E. at 1900.8 vs set a Mesquite post marked 42 on the North side, W on the East side and H on the West side;

Thence on, same course (S.O^O O9' 19" E.) through scattering Mesquite, at 1849.5 vs cross fence between said Estefana L. de Garza and and Romulo Garza, about S. 72-3/4° E., at 1900.8 vs set a Mesquite post marked 43 on the North side W on the East and H on the West;

Thence on same course at 1596 vs cross small pasture fence, at 1900.8 varas set a Mesquite post marked 44 on the North side W on the East side and H on the West side;

Thence on same course at 586 vs into field, at 729.3 vs set a Mesquite post marked W on the N. E. side, and H on the West and South sides for the S. W. corner of Willacy County, which post is 3 miles N. 9° 27' E. of the North line of Las Mestenas Grant in the name of Vicente Hinojosa, and South line of San Salvador del Tule;

Thence parallel to the said line dividing Las Mestenas Grant from San Salvador del Tule Grant, S. 81° 03' 19" E. at 148 vs cross fence between Romula Garza and Eduardo Cantu, about North and South, at 1424.5 varas set a Mesquite post marked W on the North side, 7 on the East side and H on the South side:

Thence on same course, at 1512.4 vs cross field fence, at 1900.8 / vs set a post marked W on the North side, H on the South side and 6 on the East side:

Thence on, same course, (S. 81° 03' 19" E.) at 21.8 vs cross fence betweenEduardo Cantu and the Stillmans about right angles to our line, at 1900.8 vs set a post marked W on the North side H on the South side and 5 on the East side;

Thence on, same course, through scattering Mesquite at 355 vs cross road to Tordilla, at 1900.8 vs set a Mesquite post marked W on the North side 4 on the East side and H on the South side;

Thence on same course at 1200 vs cross a fence about right angles to this line at 1900.8 vs set a Mesquite post marked W on the North side, 3 on the East side and H on the South side;

Thence on, same course, at 207.8 vs cross a fence about right angles to our line, at 1900.8 vs set a Mesquite post marked W on the North side H on the South side, and on the East side:

Thence on, same course, at 1687.6 vs cross fence between the Stillmans and F. Yturria, on the East line of the San Salvador del Tule Grant, 3 Mile N. 9° 27' E of the N.E.corner of Las Mestenas Grant, which corner is a large post of Mesquite Marked C on the West side. T on the S.W.side and M on the N. E. side; at 1900.8 vs set a Mesquite post marked W on the North side 1 on the East side and H on the South:

Thence on same course, (S. 81° 03' 19" E.) at 1900.8 vs set a Mes-

quite post marked W on the N. E. side, and H on the S.W. side, for a common corner of Willacy and Hidalgo Counties;

Note- The line as above given as a matter of fact was actually run N. 81° 03' 19" W. from this last point, which is on the line dividing Hidalgo and Cameron Counties, until it intersected the West line of Willacy County, as above stated, which accounts for the posts being numbered from the East to the West, but as a matter of convenience the line is made to read as above given.

Thence with the original line dividing Cameron and Hidalgo Counties, S. 0° 14' 49" E. at 1024 vs pass an old iron pipe 4 inches in diameter set in the ground, said pipe marked 35 and being one of the monuments on the said line between Cameron and Hidalgo Counties,

Thence on, S. 0° 14' 49" E. at 1830.8 watset a Mesquite post marked W on the N. E. side, C on the S. E. side and W on the West side, being an in corner of Hidalgo County, and Willacy County, and the N. W. corner of Cameron County;

Here Mr. W. W. Vann, the Surveyor appointed by Cameron County to assist in running the line between Cameron and Willacy County, joined in the survey, and was present at the preliminary work to locate said South line, and at the setting the N. W. corner of Cameron County as stated on page 3 which corner is 69.6 vs N. O^O 14' 49" W. of an iron pipe 4 inches in diameter set in the ground, and a mark on the said line between Cameron and Hidalgo Counties;

Thence, from the said post, N. 88° 59' 41" E. at 973 vs pass over the N.W. corner of share No. 1 of 13,908.5 acres in the name of H. E.Woodhouse of the partition of the San Juan de Carrocitas Grant, also a corner of share No. 59-1 of the same partition of same grant in the name of F. Yturria, at 1900.8 vs set a Mesquite post marked 1 on the West side W. on the North and C on the South side:

- Thence on, same course, N. 88° 59' 41" E. at 1900.8 vs set a Mesquite post marked W on the North, C on the South and 2 on the West sides:
 - Thence on, same course, at 1900.8 vs set a Mesquite post, marked 3 W on the North side C on the South, and 3 on the West side:
 - Thence on, same course, at 1900.8 vs set a Mesquite post marked W on the North side, C on the South side and 4 on the West side;

Thence on, same course, at 284.4 vs into field, at 869.7 vs pass over the N. E. corner of said share No. 1 in the name of H. E. Woodhouse as aforesaid, at 1330.6 vs set a post marked W on the North, C on the South, under the West fence of the right-of-way of the St.Louis, Brownsville and Mexico Ry., at 1349.7 vs the West rail of said Ry. course N. 6° 53' 41" E. at 1349.7 vs the East rail, at 1900.8 vs set a Mesquite post marked W on the North, C on the South and 6 on the West;

Thence on, same course, (N. 89° 59' 41" E.) at 392 vs set a Mesquite post marked W on the North C on the South, on the East side of the road Punta del Monte to Yturria, at 1900.8 vs set a Mesquite post, marked W on the North, C on the South and 7 on the West side;

Note-Here having received notice that Mr. Blucher, the Surveyor appointed by the Commissioners of the new County of Brooks, was ready with his party to run the East line of Brooks County which is also the West line of Willacy County so far as the Counties run together, it was agreed by the Commissioners of Willacy County, that A. M. French should go and join Mr. Blucher in the survey of that line, and it would be satisfactory to the Commissioners of Willacy County, that the said W. W. Vann should run the remainder of the line between Willacy County and Cameron, by himself;

Thence on across Laguna Madre, N. 88° 59' 41" E. (the distance was too great and the water and wind too high to triangulate ac-curately though I worked for three days, Vann's notes) about 6 miles and 1200 varas to the West shore of Padre Island, and on across same 5000 vs to the East shore of said Padre Island, on the Gulf of Mexico making the South line of Willacy County, along and adjoining Cameron County about 38 Miles and 800 vs;

Then to the N. W. corner of Willacy County, and N. Thence on, S. 89° 35' E. at 200 vs road Santa Rosa to Riviera, N. E., at 660 varas South end of pond, at 1900.8 vs set a Mes-quite post marked N on the North, W on the South and 10 on the West:

Thence East at 300 vs enter brush at 1900.8 vs set a Mesquite post marked N on the North, W on the South and 17 on the West;

Thence East, at 750 to 800 vs pond at 1900.8 vs in pond and can set no post;

Thence East at 100 vs set a Mes. post marked N on the North, W on the South, and 18 on the West; at 106 a pond, at 908 across same, at 1900.8 vs set a Mesquite post marked N on the North, W on the South and 19 on the West;

Thence East, at 703 to 1100 vs a deep lake, at 1368.5 vs a fence runs N. 14-1/2° E. at 1560 vs summit of Loma Prieta, at 1900.8 vs set a Mesquite post marked N on the North, W on the South and 20 on the West;
