were Unanimously passed, and entered on
the Minutes of said Court to wit,

" Hiram McMillan, Esq. County Survey
" or of Wood County, who was Appointed by
" the County Court of Hopkins County Texas
" on the 8th day of January, A. D. 1861, to Ascertain
" Survey, Mark and better define the boundary
" lines of said Hopkins County, of which fact
" this Wood County Court, was duly notified
" according to Law, and at its February Term
" 1861, duly Appointed Gilbert Yarborough Esq
" of Wood County, to meet said Hiram McMillan
" at the time, & place, designated in said Notice, to
" Aid in running & marking the boundary line
" between Wood, & Hopkins Counties, = Having
" now made his Report thereof, = which as
" appears from a Certified Copy of the same,
" has been duly received, Approved, and
" Confirmed by said Hopkins County Court
" at its regular May Term, A. D. 1861.
" It is therefore Ordered and Decreed
" by Wood County Court, that, that portion

" of said Report- as relates to the boundary line
 " between Wood and Hopkins Counties, be and
 " the same is hereby Approved, and Confirmed,
 " and further Ordered that said portion of
 " said Report, together with the field notes
 " thereof, and the Certified Copies of Hopkins
 " County Court, and Certificate of record
 " be recorded by the Clerk, on the Minutes
 " of this Court. And that the said line, be hereaf-
 " ter known & recognized, as the true & legally
 " established boundary line between Wood &
 " Hopkins Counties. -
