W. S. Cecil, Special Surveyor,
appointed by The Commissioners Court of Archer County,
Texas, and C. P. Benson, Special Surveyor, appointed by
The Commissioners Court of Young County, Texas, to re-
trace and establish, according to law, the boundary line
between the Counties aforesaid, beg leave to submit
the following report and Certificate of work actually done
by us on the ground, April 19, 20 & 21, A. D. 1894, for the
purpose of identifying the North West Corner of Young
County as established by Jas. H. Swindells, Mar. 16-20
A. D. 1857. Beginning at a rock mound on top of
mountain in west line of Young County, from which
a large flat rock, marked XXIV bears North 30° W. 20 varas,
(This point is identified as the one called for and described
by said Swindells as the 24 mile stone in said west line
of Young County); Thence North at 255 varas cross
[Camp] Creek near its mouth, Course S. W. at 300 varas Brog-
os River, Course S. W. 1900.8 varas. XXV mile post in bed of Brog-
os River, C. South. Cottonwood bearing trees not found. The River
flows through a loose sandy bottom, with force of current
against east bank which has washed or worn away from
30 to 70 varas to the eastward, destroying all the timbers that
may have been on said east bank. Thence North in river
channel at 1245 varas north bank of river, where it changes
Course from $S 50^{\circ} E.$ to $S. 8^{\circ} E.$ 1900.8 varas stake in valley for XXVI
mile post from which a large Elm marked Y. C. L. bears
N. $26^{\circ} 45' E.$ 192 7/10 varas. - Elm found and identified, but Hack-
berry bearing gone; Thence North at 1540 varas Cross Spring
Creek, C. S. W., at 1590 varas Cross same Cr., C. S. E., 1655 varas
Cross same, C. S. W. 1900.8 varas. Stake on prairie for XXVII
mile post. (no bearings found); Thence North 1900.8 varas
stake for XXVIII mile post. (no bearings found); Thence
North at 1760 varas Cross Spring Creek, Course (for a distance
72 varas.) East. 1900.8 varas a stake for XXIX mile post. from

which a mesq. stump about 10" in diameter bears N. $74\frac{1}{2}$ W. 38 vs. another, smaller stump, bears S. $64\frac{1}{2}$ E. 8 vs. - This corresponds with calls in original field notes; Thence north at 280 vs. branch, course west, - at 575 vs. as Creek, C. S. W. 595 vs. Creek, C. S. E. 1900. 8 vs. as. North west corner of Young County, a stone set on rock in rock mound, the same described in field notes sent to the G. L. O., by subscribers, for the north line of Young & the South line of Archer Counties.

The Mesquite bearings called for at this corner have been destroyed by fire, or otherwise; the remains, or signs, of mesquite are found near the corner.

The accompanying sketch, marked "Exhibit A." shows truly and correctly the location of the west boundary line of Young County (from the 24 mile post to N. W. corner), relatively to its bearings, River & Creek calls, as set forth in its original field notes, made by Jas. H. Swindell, and as found by us to exist, from work actually done by us on the ground, according to law, with Chain Carriers duly qualified, April 19, 20 & 21 A. D. 1894. And we, and each of us do hereby certify that the above and foregoing is a true and correct statement, as witnesses our official signatures this 26 day of April, A. D. 1894.
