6 It is ordered by the Court that the  
7 following agreement, entered into between  
8 a majority of the members of the Commis-  
9 sioners Court of Kerr County and a  
10 majority of the members of the Commis-  
11 sioners Court of Kendall County, made  
12 at Comfort Texas on February 15<sup>th</sup> 1894.  
13 for the purpose of permanently settling the  
14 question about the division line of Kerr  
15 and Kendall County, be approved in full  
16 and made part and parcel of this order,  
17 by being spread on the minutes of the  
18 Court, as follows:

19 Comfort Texas, February 15<sup>th</sup> 1894  
20 Whereas differences exist in regard to the  
21 location of the County lines of Kerr  
22 and Kendall County and whereas both  
23 Counties, through their Commissioners  
24 Courts are desiring and willing to  
25 permanently settle the controversy,  
26 Therefore, it is ordered by the Court,  
27 upon motion properly put and unani-  
28 mously carried, that the County Surveyors  
29 of Kerr and Kendall Counties, meet  
30 at the South line of Gillespie County  
31 and North line of Kerr and Kendall  
32 County, to establish the N.E. Corner of

1 Kerr County, being also the New Corner  
 2 of Kendall County, on said South line of  
 3 Gillespie County, said line being the  
 4 corrected line, as agreed on by Kerr  
 5 and Gillespie County. Said Corner to  
 6 located on said South line of Gillespie  
 7 County, by extending due North the  
 8 division line of Kerr and Kendall County  
 9 as run and agreed on by both Counties  
 10 in 1886. And the Surveyors of Kerr and  
 11 Kendall County, are instructed to make  
 12 the necessary change in said Survey of  
 13 1886, caused by the extension of the Division  
 14 line to the new South line of Gillespie  
 15 County. The Surveyors of both Counties  
 16 are further instructed to complete their  
 17 work, before the next regular Term  
 18 of the Commissioners Court of Kerr and  
 19 Kendall County and to present and file  
 20 their report and field notes, at said  
 21 Term for final approval.

22 The Clerk of the Court is hereby instructed  
 23 to make out a correct Transcript of  
 24 this order and transmit it at once to  
 25 Commissioners of General Office.
